This is in connection to your email memorandum dated October 06, 2021 relative to 8888 Hotline Citizen's Compliant of a certain Emelyn Salamatin Salvador resident of Bgv. Tagumpay Coron Palawan, instructing this office to conduct immediate investigation on the above cited subject.

Please be informed that this office had already acted on the issue several times. As to the memorandum dated February 18, 2015 of this office clarifies some details, about their long time issue for a GENERAL VERIFICATION SPECIAL ORDER (RSO), Inventory, Survey and to have a tax declaration and title over the claimed area located at Kalve gasgasan. Purok 1 Bgv Lagumpay Coron Palawan. However, multiple complaint with different founder of areas barangays have emerged regarding this issue, this include Ms. Emelyn Salamatin Salvador one of the founder in the said location of this group and complaining in this office without any legal papers submitted or attached with their complaint, other than the list of all the members or application forms, for registering at Securities Exchange Commission (SEC). Further, the area concern of Ms. Emelyn Salamatin Salvador is said to be covered by a title OCT No. 339, as per letter dated September 19, 2014 of this office.

In addition, the endless complaint of Mr Wagwag group in different areas and barangays affect the facts of issues and main concern, even this office already informed them on the legal process to be done in accordance with the laws, rules and regulations, relative to their request addressed to their founder Mr. Demetrio Wagwag and Flus F. Dua President of the said group way back August 14, 2019.

On the other hand, it will be recalled that as per your memorandum dated February 24, 2021 which was endorsed to the Regional Executive Director of MIMAROPA Region, furnishing a copy of certification from the Office of the Securities and Exchange Commission (SEC) dated September 30, 2019, as well as all the CENROs Palawan through memorandum and letter for the City Mayor of Puerto Princesa Palawan. National Bureau Investigation (NBI) and Atty Clarides of Legal Services Group of HUDCC (Housing and Urban Dev i Coordination Council) with regards to the certification of Non-registration of this Company of National Legal Process of Appeal (NALL) PAPa, informing this office that they are not registered in the said commission that



This refers to the alleged land problem of Mr. Gil Palean/Mr. Demetrio Wagwag et. al. in Sitio Bayo- Bayo 1, Tagumpay, Coron, Palawan. According to Mr. Wagwag, this Office has slow action in addressing their land problem. This is definitely not true.

Our consolidated report dated September 13, 2013 can attest the series of action this office has undertaken to the said land problem. This also resulted to the issuance of Survey Order (Survey Order No. 2013-10-014) dated October 25,2013 issued to Engr. Allan L. Valle of the Regional Office to execute/ conduct verification/ relocation survey of the subject parcel land being claimed by Mr. Palean/ Mr. Wagwag et.al. containing a total area of 20,970 hectares. The main purpose of the actual survey is to determine on the ground the exact/ actual area of each claimant/ settler.

This is actually the next step and pre-requisite activity to be undertaken before the claimant can apply for appropriate tenurial instrument as provided for under Memoranduminstruction dated November 19, 2012 of then RED Edgardo Galeon.

However up to this writing, no actual survey was conducted yet despite the issuance of said Survey Order.

On June 24 and 25, 2014, a Regional Fact- Finding Team with representative from this Office conducted again investigation in compliance to Regional Special Order No. 077 dated March 21, 2014. A copy of their Investigation report with pertinent enclosures were officially received by this Office only the other day, February 18,2015 with recommendations to implement: 1.) the previous investigation as called for under the Memorandum-instruction of RED Galeon dated November 19, 2012 and 2.) proceed with the actual survey in coordination with the Regional Office Surveys Division of DENR -IV- B (MIMAROPA).

Again, to implement the number 1, the number 2 recommendation should be first conducted in compliance to Survey Order No. 2013-10-014 dated October 25, 2013 in as much as the Regional Office Team has already came up with the inventory of actual occupants as attested by Mr. Gil Palean and the concerned Barangay Officials. The conduct of said survey and the approval of resultant plan/map will pave the way to clarify / verify the truth about ownership/ rightful claimants of the land in question since previous investigation report by the Regional Office disclosed that subject land is owned by certain Mr. Vicente Sabas who allegedly has an approved survey plan under his name.

Other Program/ Project of the government in the area of Mr. Gil Palean/ Mr. Wagwag et.al. in conflict with the tenurial instrument to be issued to them by the DENR.

The subject area as occupied and already a community, being located within the "40 meters- No build Zone" is included in the Post Volanda Fisherfolk Settlement Program (FFSP) where occupants will be relocated to other areas. This is part of the Yolanda Comprehensive Rehabilitation and Recovery Plan of the Office of the Presidential Assistant for Rehabilitation and Recovery (OPARR). Furthermore, this is a project of the National Anti-Poverty Commission (NAPC), in partnership with the National Housing Authority, (NHA), Burcau of Fisheries and Aquatic Resources (BFAR). Habitat for Humanity including the DENR aiming to provide the fisherfolks/settlers safer housing, strong and disaster /risk resilient communities and sustained livelihood and open up pathways out of poverty.

Several meetings have been conducted to implement the program and Local Inter-Agency Committee (LIAC) has been created by the Office of Provincial Governor under the Executive Order No. 25, Series of 2014 dated June 20, 2014 signed by Hon. Jose Alvarez.



INVOLVING PATENTED/REGISTERED LANDS

This refers to requests for assistance of numerous individuals and the National Legal Process Process of Appeal (NALEPAP), purportedly represented by Mr. Demetrio D. Wagwag, based in Puerto Princesa City, involving patented and/or registered lands.

It has been observed that the CENRO Puerto Princesa City and the PENRO Palawan have a common stand on this issue and are responding to such requests without taking into consideration the provisions of DAO 2016-31.

Chapter III of said DAO provides for the procedure in the investigation of petitions involving registered patents. Section 26 thereof provides that:

Section 26. Nature of the investigation. The proceeding under this Chapter shall be merely investigative in nature which will be conducted as a fact-finding/recommendatory procedure to determine the propriety of initiating reversion proceedings.

Sections 29 and 30 provide that a verified petition shall be filed before the PENRO stating the holder of the title, his or her address, the material allegations, the law and the ground/basis/es of the petition, and the documentary and other forms of evidence to support the allegations, consisting of the following:

- Certificate to file action from the barangay concerned;
- Verification and Certification of Non-Forum Shopping;
- 3. Proof of payment of the Petition fee;
- 4. Certified true copy of the title or patent; and,
- A recent 2x2 picture of the petitioner and his/her duly authorized representative and the subject lot.

Relative thereto, please respond to similar requests in accordance with the foregoing rules and regulations.

Kalakip din po dito ay sipi ng Barangay Resolution No. 30, Series of 2013 para sa inyong kaalaman. Maliban dito kalakip din po ang listahan ng imbentaryong isinagawa ng aming tanggapan noong Ika-23 ng Mayo, 2013 at Ika-25 ng Hunyo, 2014 ng mga actual na naninirahan sa lugar na inyong ipinaglalaban. Ang mga may kulay lang po sa bago ninyong mga pinadalang papeles ng ginawan naming ng listahan ang kasama sa mga naunang imbentaryo na sya pong sinusund na opisyal na talaan.
