The Department Environment and Natural Resources MIMAROPA Region and DENR-PENRO Marinduque conducted Coastal Clean-up activity and Communication, Education, and Public Awareness (CEPA) in Brgys. Banuyo, Pinggan, Antipolo in the Municipality of Gasan, Province of Marinduque on September 14, 2022.
