- The PENRO Human Resource Merit Promotion and Selection Board (PHRMPSB) in accordance with the 2017 Omnibus Rules on Appointments and other Human Resource Actions (ORAOHRA), DENR Merit, Selection and Promotion Plan (MSPP) and other relevant Civil Service Commission rules and regulations shall be primarily responsible in the judicious and objective assessment of candidates for appointment.
- 2. The Gender and Development (GAD) Representative shall:
 - a. Ensure equal employment opportunities is strictly observed in the Merit Promotion and Selection Process; and
 - b. Maintains a sex-disaggregated database of hired and promoted personnel.
- 3. The Employees Union Representative shall:
 - a. Ensure that the Promotion and Selection Process is fair and just among officials and rank-in-file employees
- 4. The Secretariat shall:
 - a. Maintain records of the selection process which must be made accessible to interested parties upon written request and approval of the HRMPSB Chairperson and for inspection and audit by the CSC;
 - b. Conduct structured background investigation of the top five (5) applicants; and
 - c. Post a duly certified reproduction copy of the appointment and the list of appointments issued in three (3) conspicuous places of the office premises.

This Order takes effect immediately.
