The Office is continuously providing technical assistance to strengthen the capabilities of the People's Organization in the development, protection and management of their CBFMA areas with active participation and involvement of their members.

BONO-BONO MALIHUD BULALACAO COMMUNITY BASED FOREST MANAGEMENT INTEGRATED UPLAND FARMERS PRODUCERS COOPERATIVE (BMBCB-FMIUFPC)

The BMBCB-Forest Management Integrated Upland Farmers Producers Cooperative is a holder of the CBFM Agreement for Forest Land awarded on December 18, 2000, with CBFM No. RIV-PAL-CBFMA-2000-16 covering a total of 2,092.25 hectares of forest land located at three Barangays (Bono-Bono, Malihud, Bulalacao) Bataraza, Palawan. This cooperative was registered with Cooperative Development Authority with registration No. 95020-04020388 issued on September 15, 2022, however, according to the chairman their registration is no longer updated. The cooperative has sixty (60) members/beneficiaries but most of them are inactive due to family problem encountered.

The purpose of the cooperative is to encourage the production processing and marketing of agro-forestry products. The area of operation covers three (3) barangays such as Bono-Bono, Malihud, and Bulalacao all in the municipality of Bataraza, Palawan.

Conduct initial monitoring and assessment last August 12, 2022, in the CBFM area of BMB-IUFPC together with the On the Job Training of BS Forestry and BS Environment student from WPU Main-Campus Aborlan, Palawan located at Barangay Malihud, Bataraza, Palawan in which the team observed/encountered the following;

- 1. Allegedly some parcels have already been sold to a certain individual. Since there are no forest protection initiatives have been conducted by the PO, kaingin became rampant in the area.
- 2. Some of the claimants within the CBFM area but not a member of the people's organization allegedly cut trees with more or less 15-20 cm diameter for commercial purposes.
- 3. There are poles of timber stacked along the road near the water system area.
- 4. There are sacks of charcoal observed and upon interview, it came from the upland community covering the CBFMA.

It was clearly stated in the contract that its implementation shall include forest protection and under the "obligation of parties" item no. 2.1 states that the CBFM holder shall immediately assume responsibility for the protection of the entire forest land within the CBFM area against illegal logging and other unauthorized extraction of forest product, slash and burn agriculture(kaingin).

Last August 19, 2022, an investigation was conducted by MES personnel involving alleged cutting of trees and stacked of poles timber covered by the CBFM area of BMBCB-FMIUFPC. Based on the report of the investigating team, according to Chieftain Darius Ansali which present in the area during inspection/investigation, he said the observed cutting of trees and bunched of timber poles observed in the area are for personal only not for commercial purposes. The on-going construction of house is owned by his siblings in which they moved to the said area for easy access to the cemented road and to perform his duties as chieftain of the area since their previous household located in remote and hard to access area in the lower portion of the forest. He further stated that continuously monitored and conduct forest protection activity to the forest cover.

Upon assessment of the investigating team, the said timber poles and cutting of trees are intended for personal construction and repair of house of the local Indigenous People of the said area although we can still assumed that there are also intended for commercial purposes which violates the section 77 & 78 of PD 705 (illegal cutting of trees and forest occupation)



The team also monitor the Kapangyan falls within the CBFM area. The LGU Bataraza facilitate the maintenance and protection of the falls and one of the PO member is a caretaker as their PO counterpart

On August 18, 2022, conduct another monitoring and assessment in the CBFM area together with the On the Job Training of BS Forestry and BS Environment students from WPU Main-Campus Aborlan, Palawan located at Barangay Bulalacao, Bataraza, Palawan. Short dialogue with one of the members of the cooperative. According to him, the cooperative members during their last meeting were opposed to engaging in some farming projects which serve as an alternative source of livelihood but no specific project has been decided by the cooperative. Unfortunately, were not able to talk to the chairman during monitoring due to sickness.

On August 19, 2022, Monitoring and assessment in the CBFM area located at Barangay Bono-Bono, Bataraza, Palawan in which the team also observed/encountered the following;

- 1. There are actually tilling land within the CBFM area but they have occupied/claimed areas within CBFM that they had bought from some cooperative members
- 2. Some of the members and claimants have allegedly sold portions of the CBFM area to some individuals
- 3. Lacking of forest protection activities within the tenured area. No initiatives have been conducted by the PO
- 4. The People's organization is no longer active in the operation of the CBFM project

It was clearly stated in the contract that its implementation shall include forest protection and under the ''obligation of parties'' item No. 2.1 states that the CBFM holder shall: ''Immediately assume responsibility for the protection of the entire forest lands within the CBFM area against illegal logging and other unauthorized extraction of forest product, slash and burn agriculture (kaingin). and under item No. 6 under "Termination of contract—The CBFMA may be terminated based on the non-performance of the PO. Based on the contract it was the responsibility of the cooperative to protect the area.

In addition, it was observed from the list of the members of the cooperative submitted to this office that some members are not residing within the CBFMA or adjacent Barangay. Per implementing Rules and Regulation (IRR) DAO 96-29 of EO 263, in order to participate in the CBFM project, a PO must have the following qualifications:

- 1. Members shall be Filipino citizens
- 2. Members may either be:
 - a. Actually tilling portions of the area to be awarded;
 - b. Traditionally utilizing the resource for all or a substantial portion of their livelihood; or
 - c. Actually residing within or adjacent to the areas to be awarded.

In this regard, the undersigned recommends that an evaluation of the CBFMA be conducted to assess the overall performance of the holder as well as the issue of the qualification of their members to participate in the CBFM.

The team monitors one of the projects implemented within the CBFM area;


CBFM-CARP Project

In 2011, the BMBCB-FMIUFPC was one of the cooperatives chosen for the CBFM-CARP project of Cashew and Marang Plantation in Combination with Agri-crops with a total area of 50 hectares located at Barangays Bulalacao and Maihud, Bataraza, Palawan. For now, the PO members harvesting "Pine Apple" which they sell in the market, and Calamansi which serves as one of the sources of family income for the members residing within the CBFM area and non-members who have claims within the CBFM area.

Additionally, the BMBCB-FMIUFPC is again a recipient of the 2018 CBFM-CARP project entitled "Indigenous Tree Plantation Combination with Agro-forestry" with a total area of 50 hectares located at Bono-Bono, Bataraza, Palawan. Right now, lacking of maintenance activities within their tenure area claimed/occupant.



NATIONAL GREENING PROGRAM

The BMBCB-Forest Management Integrated Upland Farmers Producers Cooperative is one of the contractors/partners in the implementation of the NGP project since its launching in 2011 for the comprehensive site development of open areas identified within their tenured areas. The program provided the people's organization a livelihood and additional income for to its members. This involves the employment of some women in the seedling production or nursery operation and tree planting activities while the site preparation as well maintenance and protection activities were undertaken by the end of the families. Non-members with claimed or occupied areas within the tenured area were also employed/hired in the nursery operation and plantation establishment.

There are nine (9) established NGP Projects within the CBFMA area as enumerated in the table below:



- 6. Preparation of a detailed work plan for each officer to assist/guide them to function more effectively and efficiently.
- 7. All members and Officers must be active in the CBFM project.
