Respectfully forwarded is the memorandum dated September 14, 2022 from CENRO Brooke's Point, Palawan relative the above subject.

Per memorandum, CENRO Brooke's Point received an explanation on September 05, 2022 from Police Staff Sergeant Rosbel C Baleros explaining that the alleged utilization of confiscated evidence is not true. According to PSSgt. Baleros, some of the evidences were already in decomposition stage, since it was confiscated almost four (4) years ago and also contributed the deterioration was a flood happened in year 2020. (Please refer to the attached CENRO memorandum dated June 27, 2022 together with the letter from P/Lt. Nollie S Vergara of Sofronio Española MPS and the replied letter from PSSgt. Baleros of 401st B MC, RMFB Taytay, Palawan dated June 21, 2022)

This pertains to the memorandum dated April 26, 2022 of Regional Executive Director Lormelyn E. Claudio, CESO IV instructing to coordinate with the In-charge of PNP Sofronio Española MPS and submit a written explanation as to why the apprehended lumbers have been utilized for the construction of the garage of PNP Sofronio Española MPS without consent from this office (DENR field office having jurisdiction) pursuant to existing ENR policies on the matter.

Pleased be informed that this office has sent a Memorandum dated June 27, 2022 affirming letter of Police Lieutenant Nollie S. Vergara, Officer In- charge stating that he has no personal knowledge on alleged utilization of confiscated evidence considering that they assume his duty as Officer In- charge of Sofronio Española Municipal Police Station last February 8, 2021 and investigator of the said case PSSg Rosbel C. Baleros was already assigned at Regional Public Safety Battalion, Taytay, Palawan shall be requested to appear in Sofronio Española MPS for clarification and to shed light the above mentioned alleged utilization of confiscated evidence. Also stated that, they will submit the report soon as they obtain the justification from the assigned investigator on case.

On September 05, 2022, this office received an explanation letter dated June 21, 2022 of Police Staff Sergeant Rosbel C. Baleros stating that the alleged utilization of confiscated evidence is not true, some of evidence were already in decomposition stage

considering that it was confiscated almost four (4) years ago on November 17, 2018. For more than three (3) years said evidences was still at Sofronio Española premises in rain or shine and in flood or sunny season, there is no proper room for a large scale evidences. He further stated that on year 2020 because of the flood in Sofronio Española MPS premises they requested to LGU to fill a soil for ground improvement, the sizes 2x5x20 Palawan Cherry was pressed by a heavy equipment Pison Truck caused to cut off the said lumber. The other species still in the said station subjected for turn- over.


