




Respectfully forwarded is a copy of Resolution No. 44-2022 approved by the Sangguniang Panlungsod of Puerto Princesa City entitled "*A Resolution requesting the Department of Environment and Natural Resources to amend DENR Administrative Orders and to relax or lessen the requirements in securing permit relative to the utilization of Non-Timber Forest products within the areas covered by the Ancestral Domain*".

The said Resolution aims to ease the requirements for of the Indigenous Peoples Organization/s in securing permits for Non-Timber Forest Products (NTFP) such as Performance Bond. Like in the case of the Samahan ng mga Katutubong Batak sa Manggapin in Brgy. Langogan (SKBML), this City, the association was required to pay the Performance Bond amounting to PhP1,800,000.00 pesos prior to the issuance of Tapping, Extraction, Collection (TECP) of almaciga resin.





RESOLUTION NO. 44-2022

A RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO AMEND DENR ADMINISTRATIVE ORDERS AND TO RELAX OR LESSEN THE REQUIREMENTS IN SECURING PERMIT RELATIVE TO THE UTILITIZATION OF NON-TIMBER FOREST PRODUCTS WITHIN THE AREAS COVERED BY THE ANCESTRAL DOMAIN.

WHEREAS, Article II, Section 22 of the 1987 Philippine Constitution declares, that: "The State recognizes and promotes the rights of indigenous cultural communities within the framework of national unity and development";

WHEREAS, Section 2 of Republic Act No. 8371, known as "The Indigenous Peoples' Rights Act of 1997," declares, that: "The State shall recognize and promote all the rights of Indigenous Cultural Communities/Indigenous Peoples (ICCs/IPs)";

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, the Indigenous Peoples Rights Act of 1997, or IPRA Law, and other international covenant/treaties have provided IP communities the basis of their legal rights to assert and protect of whatever belong to them;

WHEREAS, to secure permit from the Department of Environment and Natural Resources (DENR) to utilize non-timber forest products within the areas covered by the Ancestral Domain entails tight or numerous requirements, which means burden to the indigenous people;

WHEREAS, to recognize, protect and promote the rights of Indigenous Cultural Communities/Indigenous Peoples, and to ease their burden in securing said permit, this Sanggunian deemed it appropriate to pass this measure;

NOW THEREFORE, on motion of Hon. Herbert S. Dilig, City Councilor, Assistant Majority Floor Leader, Acting Majority Floor Leader,

BE IT RESOLVED, as it is hereby resolved, to request the Department of Environment and Natural Resources to amend their DENR Administrative Order and relax or lessen the requirements to secure permit relative to the utilization of non-timber forest products within the areas covered by the Ancestral Domain.




