





This pertains to the above subject in relation to the target activity under “Implementation of the Multi-Sectoral Resolution in Forest Protection”.

Please be informed that the undersigned facilitated the conduct of Multi-Sectoral Forest Committee (MFPC) meeting held at CENRO Conference Hall, Barangay Poblacion, Taytay, Palawan dated August 31, 2021. It was participated by the members of the Committee from the agency of the Philippine National Police (PNP), Philippine Coast Guard (PCG), Regional Marine Force Batallion (RMFB), Municipal Environment and Natural Resources Office (MENRO), Palawan Council for Sustainable Development (PCSD), Academe, People’s Organization (POs) such as Malampaya-Pancol Multi-Purpose Cooperative, Bato Multi-Purpose Cooperative, San Fernando Agro-Forestry Producers Cooperative, Samahan ng Magsasaka at Mangangisda na Nangangalaga ng Likas-Yaman and some personnel of this Office.

The activity was welcomed by the Development Management Officer IV Mariano P. Lilang Jr emphasizing the commitment of each member to create resolution that will serve as a guide in the protection of the environment and natural resources and the responsibility that lies on it. In the morning session, the Department Administrative Order (DAO) 95-17 and the governing sections related thereof was tackled and explained by the undersigned. Further, the **Resolution No. 2** Series of 2021 entitled “Addendum to the members of Multi-sectoral Forest Protection Committee (MFPC)” was presented and discussed to the body. Without further details, ideas and comments, the group approved and adopted the said resolution. As the discussion comes to its highlights, different insights, comments and opinions were noted. Among are the regulation on the use of the chainsaw, confiscate chainsaw sellers, issuance of chainsaw permit, make use of the fallen trees caused by Typhoon Odette, inclusion of the Barangay Local Government Unit (BLGU) in the next meeting that can help to intensify the protection on our environment. In the afternoon session, the academe committed their involvement to the committee by promoting environmental awareness thru Information and Education Campaign (IEC) and the participation of the students in a tree planting activity. The undersigned opened the nomination and suggested to have a separate Multi-Sectoral Forest Protection Committee for Taytay and El Nido but under the supervision of the body. Without further clarifications and recommendations, the body agreed and it was moved and seconded hence the 3rd resolution will be submitted once finalized and signed by the participants.

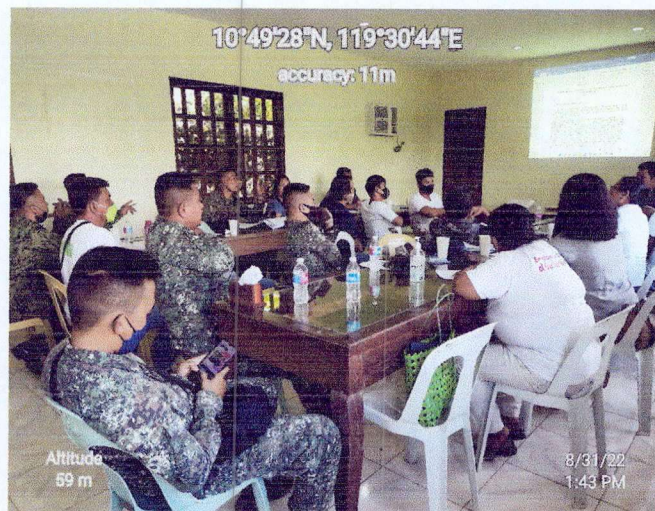
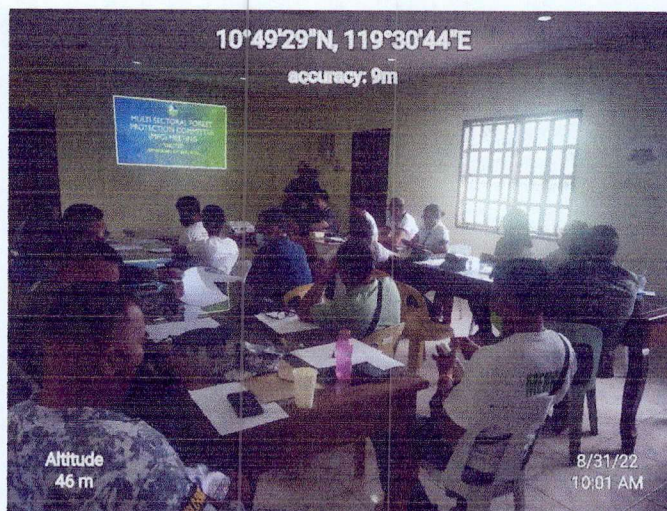
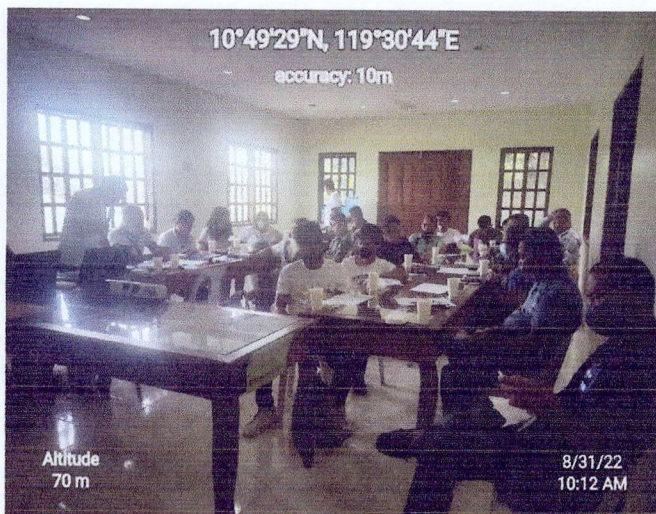
