Please be informed nineteen (19) members of the Protected Area Management Board (PAMB) served as respondents to the METT Forms, namely Data Sheet 2: Protected Area Threats and Assessment Form during the MEA held on August 30, 2022 at Triple L Resort, Barangay Poblacion II, Victoria, Oriental Mindoro. The total respondents represent 61.29% of the thirty-one (31) members of the PAMB of NLNP. The total number of respondents is sufficient to generate analysis as it complies to the minimum representation prescribed per Section 4 of BMB TB No. 2018-05, which requires a majority of the stakeholders, at least 50% + 1 of the members of the PAMB.

The overall management effectiveness rating of NLNP is 53.22% which is equivalent to a *good* status. This is 2.37% points higher than the recomputed management effectiveness rating of NLNP in 2019 at 50.85%.
