REPORT ON REQUEST OF MR. DANILO P. MAGBUDHI TO CONDUCT LOT SURVEY AT LOT NO. 2198, CSD-04-000053-D

AT BARANGAY BANGKAL, SAN JOSE

In connection with the above-mentioned subject, I have the honor to report the following:


- 1. That on May 23, 2022, Mr. Danilo Magbudhi and his siblings first wrote to the office of the CENRO requesting to conduct survey on the lot inherited from their late father, Mr. Nazario Magbudhi. The letter stated that the siblings want to apply for individual titles for the said lot. The subject lot is located at Barangay Bangkal, San Jose, Occidental Mindoro.
- 2. That along the letter request, the Magbudhi siblings submitted a certification from Barangay Bangkal, signed by Honorable Captain Lito E. Robles, stating that Mrs. Nimfa M. Abos, Emelita M. Insigne, Alicia Magbudhi, Cora M. Base, Ma. Elena Magbudhi and Danilo Magbudhi are the actual occupant of Lot No. 2198 with an area of 113, 471 square meters.
- 3. Upon receiving the request, the undersigned tried to contact Mr. Magbudhi on his contact number provided in the letter to schedule the conduct of ocular inspection and geotagging of the subject lot but the contact number is always unattended and did not reply to any messages.
- 4. On July 27, 2022, Mr. Magbudhi again wrote to the Office of the CENRO to reiterate their request for lot survey. The letter of Mr. Magbudhi was received by the Office on August 02, 2022. This time, the undersigned personally talked with Mr. Magbudhi to schedule the conduct of ocular inspection/geotagging of lots since the reception/signal in Brgy. Bangkal is very poor to none.
- 5. On August 10, 2022, the undersigned travelled to Barangay Bangkal, San Jose, Occidental Mindoro to conduct lot inspection and geotagging of Lot 2198-A, Csd-04-000053-D and found out the following:
 - a. That the Magbudhi siblings are the actual occupant of Lot 2198-A, Csd-04-000053-D.
 - b. That Mr. Magbudhi and his siblings planted different species of trees in the area and some parts are used to grow plant rice during rainy season.

- c. That the Magbudhi siblings want to divide Lot 2198-A, Csd-04-000053-D to the surviving heirs of Nazario Magbudhi prior to application for land title and they want to avail the free public land survey of DENR.
- 6. That based on the geotagged photos taken on the area and through projection of the GIS Staff in this Office, Lot 2198, Csd-04-000053-D covering an area of 113, 471 sq. meters is within the Alienable and Disposable Area per LC Map 600, Project 9-A certified on June 9, 1929.
- 7. The based on the existing records of this office, Mr. Nazario Magbudhi is the sole claimant of Lot 2198-A, Csd-04-000053-D containing an area of 113, 471 square meters.

In view hereof, it is recommended that Lot 2198-A, Csd-04-000053-D be included in the PLS project for subdivision to the Magbudhi siblings prior to application for land titling. Mr. Magbudhi was also informed about the land classification of Lot 2198-A, Csd-04-000053-D and this recommendation.


