
Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated September 20, 2022 relative the above subject.

Per memorandum, the apprehension was made on August 10, 2022 at around 2:00 P.M. in response to the relayed information from FR Michael Fernando regarding the abandoned Black Nissan Van loaded with Ipil lumbers at Purok Masikap, Barangay San Jose, Puerto Princesa City, Palawan. The team composed of MES personnel of CENRO Puerto Princesa, Naval Forces West and PNP Intelligence apprehended the said abandoned vehicle loaded with twelve (12) pieces of Ipil lumbers with equivalent volume of 128.48 board feet.

The estimated fair market value of vehicle is Php250,000.00 while the lumber is Php19,272.00. The apprehended items were brought to the compound of CENRO Puerto Princesa for safekeeping purposes.

Three (3) notices to the public were posted in different public places on August 15, 2022, August 25, 2022 and September 12, 2022 in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended vehicle and lumbers.

Respectfully forwarded is the summary of administrative hearing of the apprehended one (1) unit Black Nissan Van loaded with twelve (12) pieces Ipil lumber in Purok Masikap, Barangay San Jose, Puerto Princesa City.

No claimant/ owner was present during apprehension. The vehicle was abandoned. Despite posting of notice to the public for three (3) consecutive weeks, no claimant appeared to this office. Hence, the Black Nissan Van loaded with 12 pieces ipil lumber with corresponding volume of 128.48 board feet was declared abandoned.

In view of foregoing, the undersigned concurs with the recommendation of the hearing officer that the apprehended Black Nissan Van and the Ipil lumbers will be confiscated in favor of the government.

5. **HOW:** At around 2:00 pm, FR Michael Fernando relayed an information regarding the abandoned Black Nissan Van loaded with Ipil lumbers in the above-mentioned area. The undersigned immediately responded to the report together with PNP intelligence (PCSMS Sunny Miranda and PCPL Richard Temple) and Naval Forces West NISG Cris Madrigal.



At the area, the team positively confirmed a Black Nissan Van with an open door at the back, no plate number and loaded with Ipil lumbers. The team conducted investigation around the area regarding the vehicle, several people nearby were interviewed. Then someone said the van was of Dodong, however they unable to identify him well and they don't know his whereabouts.


Since there was no claimant, thus the team apprehended the said vehicle together with its load. The team inventoried the Twelve (12) pieces of Ipil lumbers with corresponding volume of One hundred twenty-eight-point forty-eight (128.48) board feet and brought it to the CENRO office for proper disposition and custody.

Respectfully submitted is the Summary of Administrative Confiscation Proceedings together with the pertinent documents anent the above –cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The apprehension was made by the personnel of DENR CENRO Puerto Princesa, elements of PNP Intelligence Group and Naval Forces West of Puerto Princesa City on August 10, 2022 at around 2:00 in the afternoon at Purok Masikap, Barangay San Jose, Puerto Princesa City. Based on the report, the team responding to a report, apprehended one (1) unit Black Nissan Van, no plate number and loaded with ipil lumbers with corresponding volume of 128.48 board feet. Furthermore, based on the information gathered by team, the black Nissan van allegedly owned by certain “Dodong” according to some nearby residents they have interviewed during apprehension. However, aside from the nickname of the owner, no other information was gathered. Hence, the team declared the vehicle and its load as abandoned items.

II. NOTICE OF HEARING

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: rules for Administrative Adjudication of Illegal forest Products and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 8, Item #3. Posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this office at the CENRO PPC bulletin board, Brgy. Hall of Barangay San Jose, and Monitoring Station of Sta. Lourdes, Puerto Princesa City.

III. EVALUATION

In spite of the notices posted, no claimant has appeared on this Office to claim ownership of the apprehended Black Nissan loaded with 12 pieces ipil lumbers. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the item apprehended in favor of the government.

IV. RECOMMENDATION

In view hereof, it is recommended One (1) unit Black Nissan Van loaded with 12 pieces Ipil lumbers apprehended at Purok Masikap, Barangay San Jose, Puerto Princesa City be confiscated in favor of the government.
