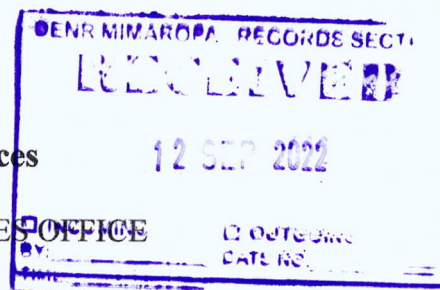

Respectfully forwarded is the memorandum of CENRO Taytay dated May 4, 2022 in connection the above subject.

Please be informed of the following matters, to wit;

1. CENRO Taytay has Forty-Two (42) cases encoded in the e-FMS as of May 4, 2022.
2. There are six (6) Forest Product Monitoring Stations maintained and manned by the enforcement personnel.
3. Continuous conduct of patrolling activities in connection to LAWIN Forest Biodiversity Protection System with corresponding actions and response to identified threats. A total of 305 km. distance patrolled with typhoon-related threats recorded.
4. Consultative meetings with other stakeholders were also conducted to discuss illegal poaching within Timberland and Protected Areas.
5. Continuous Information and Education Campaign (IEC) was also conducted in the community to inform them regarding the ENR Laws.

This pertains to the memorandum from The Undersecretary for Field Operations and Environment Atty. Juan Miguel T. Cuna, *CESO I* and The Regional Executive Director Lormelyn E. Claudio, *CESO IV* dated February 14, 2022 and April 26, 2022, respectively relative to the above subject, please be informed of the following matters to wit:

1. This Office is still on process of encoding data on the e-FMS. As of today, there are forty-two (42) cases encoded in the system.
2. There are six (6) Forest Product Monitoring Stations (6) maintained and manned by the enforcement personnel of this Office (*see attached CENRO Special Order*). Further, this Office is looking for a possible strategic location for the Forest Product Monitoring Station (FPMS) III located in So. Ibangley, Bgy. Abongan, Taytay, Palawan since the present area has no available signal.
3. This Office continued to conduct patrolling in connection to LAWIN Forest and Biodiversity Protection System with corresponding actions and response to identified threats. As of to date, this Office accomplished a total of **305** kilometers distance patrol with typhoon-related threat recorded. Coordination to the concerned Barangay LGU and development project were the action-taken of this Office.
4. Consultative meetings with other stakeholders was also conducted to discuss illegal poaching within Timberland and Protected Areas.
5. Continuous Information and Education Campaign (IEC) was also conducted in the community to inform them regarding the ENR laws.

SUBJECT : REORGANIZING AND REASSIGNMENT OF THE PERSONNEL INVOLVED IN ENFORCEMENT AND MONITORING SECTION (EMS) OF THIS OFFICE AND PROVIDING INSTRUCTIONS THEREFOR.

In the interest of the service and in order to strengthen the implementation of the environmental ecosystem and forest protection program, Enforcement and Monitoring Section (EMS) is hereby updated or reorganized, defining jurisdiction, station, providing specific instructions and responsibilities for strict adherence and compliance, to wit:

I. Units

Enforcement and Monitoring Section is responsible for the implementation of Department Administrative Order 2018-18 and to perform other functions that may be assigned by the authorities. The Section has two units in compliance to item 3.3.3 of Department Administrative Order 2019-01 namely and by the lead of:

- a) Enforcement Unit by Forester Michael L. Marasigan are responsible for supervision, preparation of plans and strategies in particular stations to curb the occurrence of illegal forestry activities and preparation of necessary documents needed in filing cases in court.
- b) Monitoring Unit by Forest Technician II Forester Christian O. Cuyo to be assisted by Forest Ranger Richard M. Pariñas are responsible for the monitoring and compliance of all permits, leases and tenure holders of the Department. The team shall be in conformity with the relevant special order creating Inspection Committee.

Both Units have the authority over the Forest Product Monitoring Stations and the Special Force.

II. Station/Grouping/Jurisdiction

The jurisdiction has six (6) Forest Product Monitoring Stations established in the strategic locations. These are under the maintenance of designated teams with Team Leaders reorganized in Annex 'A' hereof subject to reshuffling at least every three (3) months.

III. Special Force

The special force is hereby reorganized in order to strengthen its responsibilities by creating one (1) modified Quick Response Team (QRT) who shall quickly respond all calling services coming from different stations that enforces environmental and forest protection laws, policies, rules and regulations. The Forest Product Monitoring Station I in Poblacion, Taytay, Palawan shall be the Official Headquarter with support of the Team Leaders and members from Forest Product Monitoring Stations I, II, III, IV, V and VI (Annex A). Moreover, all Team Leaders and field personnel who are assigned in the different Forest Product Monitoring Stations (refer to Annex A) shall quickly respond to all environmental issue alerts anywhere in the jurisdiction of this Office upon the direction of the Chief, Enforcement and Monitoring Section and CENR Officer.

IV. Instructions

- 1) The Forest Product Monitoring Stations shall be the official field stations of the respective teams and they shall maintain attendance logbook for monitoring and records purposes; they shall maintain orderliness/cleanliness and ensure manning of the stations round the clock daily.
- 2) They shall act on all referrals and submit report of action within the timeline as per instruction but in no case shall be beyond fifteen (15) calendar days.
- 3) They shall check the completeness and authenticity of transport documents covering forest products passing by the station, register the same into the logbook, and submit information/report to the Office (CENRO) the soonest possible but in no case be beyond five (5) calendar days.
- 4) They shall strategize forest protection activities, including LAWIN, and patrolling in the marine area in the case of the stations covering Malampaya Sound Protected Landscape and Seascape (MSPLS) and El Nido-Taytay Managed Resource Protected Area (ENTMRPA); to apprehend environmental law violators, document, effect inquisition and execute affidavit/s to support the filing of case/s in court, if so warranted; and monitor wood/lumber/log sources of sash factory/ies, furniture shops and lumber yards.
- 5) Upon instruction, they shall extend assistance and support to other special programs and projects of the DENR under supervision of other Sections of the Office including special events to the attainment of objectives and targets.
- 6) They shall submit monthly accomplishment report on or about every 20th day of the month and render briefing every forum on Mondays of their activities during the preceding week.
- 7) They shall perform other functions as maybe assigned by their immediate supervisor.

This **ORDER** is immediately effective and cancels all other CENRO Special Orders inconsistent hereto and shall remain in force until revoke or amended by the undersigned CENRO.
