


SUBJECT : ADMINISTRATIVE ADJUDICATION OF ABANDONED SEVENTY-EIGHT (78) PIECES OF IPIL LUMBERS AT SITIO PULANG LUPA, BARANGAY MONTIBLE, PUERTO PRINCESA CITY (VIOLATION OF SECTION 77 OF PD 705)

Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated August 31, 2022 relative the above subject.

Per memorandum, the apprehension was made on January 06, 2022 at around 10:00 A.M. at Sitio Pulang Lupa, Barangay Montible, Puerto Princesa City, Palawan by the elements of CENRO Puerto Princesa and PNP City Mobile Force. During the apprehension, there is/are no claimant/s present and the team declared abandoned and apprehended the seventy-eight (78) pieces of Ipil lumbers with total volume of 828.12 board feet. The estimated fair market value of the apprehended lumbers has a total of Php9,360.00. The apprehended lumbers were brought to CENRO Puerto Princesa for safekeeping under the temporary custody of Forester I Lim Bryan M. Kutat.

Pursuant to Item No. 3, Section 8 of DAO 97-32, notices to the public were posted in three different locations particularly on January 14, 21 and 27, 2022. However, despite notices posted, no claimant has appeared at CENR Office to claim ownership of the apprehended lumbers. Therefore, the lumbers were declared abandoned.

We concur with CENRO recommendation for the issuance of confiscation order in favor of the government.

Respectfully submitted is the Summary of Administrative Confiscation Proceedings together with the pertinent documents anent the above -cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The DENR CENRO Puerto Princesa and PNP City Mobile Force (CMF) personnel made the apprehension on January 6, 2022 at around 10:00 in the morning at So. Pulang Lupa, Barangay Montible, Puerto Princesa City. Inventory of apprehended lumbers revealed a total of Seventy-eight (78) pieces of Ipil with a volume equal to Eight hundred twenty-eight-point twelve (828.12) board feet. During the apprehension, there was/were no claimant present, as a result it was deemed abandoned.

II. NOTICE OF HEARING

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: rules for Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 8, Item #3, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this office at the CENRO PPC office, Barangay Sta. Monica, Puerto Princesa City and Sicsican Monitoring Station.


III. EVALUATION

Despite the notices being placed, no claimant has appeared at this office to assert ownership of the lumbers that were apprehended. The owner or claimant's failure to appear is therefore regarded a renunciation of their claim to the items apprehended in favor of the government.

IV. RECOMMENDATION

In connection of this, it is recommended that the 78 pieces of Ipil lumbers apprehended at So. Pulang Lupa, Barangay Montible, Puerto Princesa City be confiscated in favor of the government.





A team then created to respond to the report. Then around 9:30 in the morning, the team proceeded to the area led by For. Kutat and FT Adato.

The DENR team arrived at the area at around 10:00 in the morning and met the team of CMFC led by PLt Col Victor N. Lacwasan and Bantay CADT led by Roel Bulagis securing the area. After a brief introduction, the team proceeded to the area and started the documentation, taking geotagged photos and inventory of lumbers. Initial Inventory revealed that there were 78 pcs Ipil lumber with different dimensions and has a total volume of **828.12 bd. Ft** (subject for final scaling).

Apprehended lumbers were delivered at CENRO compound for safety, custody and for proper disposition.
