SURVEY AUTHORITY**

This pertains to the Department (DENR) Administrative Order No. 2022-10 dated May 30, 2022 "Revised DENR Manual of Authorities on Technical Matters", particularly on page 33 (photocopy attached), Surveys and Mapping Division.

We find it confusing to differentiate "isolated/ original and simple subdivision survey of public lands" from "subdivision of cadastral lots not being the subject of judicial registration" in order to determine the issuing authority whether the PENRO or the CENRO. Meantime, we presume that most of the present survey concerns in our jurisdiction fall as a subdivision of cadastral lots in which case the PENRO shall be the issuing authority
