

WHEREAS, Republic Act (RA) No. 9322 provides that a portion of the territory of Barangay Ransang in the Municipality of Rizal, Province of Palawan consisting of 512.80 hectares of land covered by Project Number 13-G, Block A of Land Classification Map Number 3400 is reclassified as agricultural land open for disposition and directs the Secretary of the Department of Environment and Natural Resources (DENR) to issue the necessary implementing orders, rules, regulations and circulars to implement the provisions of the

Act;

WHEREAS, attention to RA No. 9322 has been stimulated when a potential investor manifested interest in operating an agro-industrial company in the municipality, initially targeting alienable and disposable (A & D) areas;

WHEREAS, issues and concerns subsequently came to light as a result of the due diligence conducted by a certain consultancy firm, such as: a) land tenurial/ownership, land release issues (IRR for RA 9322) that shall both require the assistance of the CENRO/DENR, and b) membership and organizational validation issues pertaining to the two groups of claimants/occupants (farmers associations) of the area;

WHEREAS, to expedite the long pending issuance of the IRR and facilitate the judicious distribution of the 512.80 hectares to the rightful beneficiaries, the local government provided fund for the survey and establishment of boundaries thereof;

WHEREAS, having long completed the survey by the DENR in 2018, this local government has since then been waiting for the issuance of the IRR, and the eventual distribution/awarding of the subject area to its beneficiaries;

WHEREAS, following this hiatus, on February 10, 2020, under Resolution No. 2020-016, the 15<sup>th</sup> Sanggunian requested the DENR-MIMAROPA Regional Executive Director, Henry A. Adornado, to facilitate the expeditious issuance of the IRR of RA 9322 and its corresponding map with technical description, followed by Resolution No. 2021-217, dated September 13, 2021;

NOW, THEREFORE, on motion of Hon. Arvin C. Fuentes jointly seconded by Hon. Jalil J. Insani and Hon. Zaldy C. Magbanua, be it

RESOLVED, as it is hereby resolved, to reiterate as it is hereby reiterated, the request of this municipal government thru Sangguniang Bayan Resolution No. 2020-016 with follow-up measure thru Resolution No. 2021-217 from the Department of Environment and Natural Resources thru its MIMAROPA Regional Office;

RESOLVED, FURTHER, that a copy of Resolutions No. 2016-067, 2016-086, 2017-114, 2017-169, 2020-016, and 2021-217 be hereto attached to form as integral part of this resolution;

RESOLVED, FINALLY, that the DENR-MIMAROPA Regional Executive Director, PENRO-Palawan and CENRO-Quezon, MPDO and all others concerned be furnished with copies of this resolution for their information and appropriate action.
