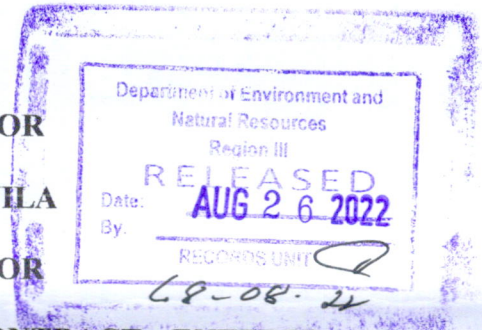

That the SECOND PARTY likewise agrees and will accept all the sawn lumber above mentioned regardless of the price therefore which will be fixed and agreed upon by both parties upon receipt by the SECOND PARTY from the FIRST PARTY, and the shipment or transportation of same including the preparation of shipment certificate and all needed papers in connection thereto, shall be under the exclusive responsibility of the FIRST PARTY; and thereto, shall be under exclusive responsibility of the SECOND PARTY; and

The term to this contract covers a period of one (1) year/s beginning from date of signing of this agreement, unless sooner terminated upon agreement by both parties.
