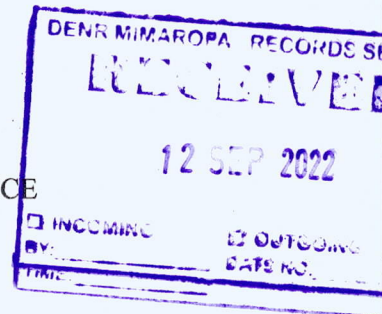

1. Reference:
a. Memorandum from Officer In-Charge, Sofronio Espanola MPS dated June 20, 2022.

2. This pertains to the letter from CENRO Brooke's Point, Palawan regarding the confiscation of four (4) pieces lumber of Palawan Cherry, Six (6) lumber of Gimelina with a total of 127.32 board feet, one unit YAMAHA RS 100 motorcycle (habal-habal) and one unit RUSI 125 motorcycle (habal-habal) apprehended in Barangay Punang, Sofronio Espanola, Palawan.

3. In connection with the above reference, please be informed that on November 17, 2018 at about 11:00 PM two Barangay Tanod namely; LORETO FLORES and ROGELIO GUMBAN apprehended the two suspects identified as Rogelio Camansi Bataluna, 37 years old, married, farmer and Edgar Paga Eklas, 37 years old, married, farmer. Both residents of Bgy. Punang, Sofronio Espanola, Palawan. The two suspects were turn-over by the two Barangay Tanod to the Municipal Police Station of Sofronio Espanola wherein the duty investigator is the undersigned. The confiscated assorted lumber were described as; four (4) pieces 2X5X20, two (2) pieces 2X4X13 and four (4) pieces of 2X5X13 and two motorcycle (habal-habal) were turn-over to Sofronio Espanola MPS under the responsibility of the Investigator-On-Case while this case was referred immediately to the Officer of CENRO, Brooke's Point, Palawan for filing of appropriate charges to those identified suspect but said evidence of the case still placed at Sofronio Espanola, Palawan.

4. On June 20, 2021 at about 12:54 PM the undersigned received an Memorandum of Explanation from Officer In-Charge of the Sofronio Espanola MPS **PLT NOLLIE VERGARA** regarding the alleged utilization of confiscated evidence. In response to this, I reviewed this case and found out that it was already referred to CENRO Brooke's Point. The alleged utilization of the confiscated evidence is not true, In fact most of the evidences like lumber were subject for decomposition considering that it was confiscated on November 17, 2018 and there is no proper room for a large scale evidences but then the undersigned knew that the said evidence still in Sofronio Espanola MPS premises in rain or shine and in flood or sunny season for more than (3) three years despite of her reassignment on September 2021 at Regional Mobile Force Battalion Taytay Palawan. The authorized person to confirm the whereabouts and status of the evidence is the undersigned and yet there is no notice of inspection or any invitation to verify the evidences.

5. I remembered on year 2020 because of the flood in Sofronio Espanola MPS premises we requested to LGU to fill a soil in our ground for improvement wherein to prevent the flood coming in our premises every rainy days, the sizes 2X5X20 was pressed by a heavy equipment of LGU (Pison Truck) caused to cut off the said lumber. The other species were now under the decomposition and yet we are requesting from your office to inspect the said lumbers in our both vacant time please contact me in my cellphone number 09101270254.


