



- 2. Conduct inspection and took some geo-photos within the area of subject lot.


FINDINGS/ RECOMMENDATION

- 2. Vilma Kiamco and their caretaker constructed a house in the subject lot.
- 3. Some coconut and other fruit trees has been observed within the vicinity.
- The applicant's possession in the area is peaceful and nobody interfered since it was purchased and occupied by them.
