**OF AUGUST 2022** 

This is in compliance with PENRO Special Order No. 010 dated February 07, 2022 relative on the creation of teams of Wildlife Traffic Monitoring Unit within the province of Marinduque covering the period of July 22, 2022 to August 17, 2022.

- On August 11-12, 2022, Forest Ranger Michael Joseph M. Maranan, Forest Protection Officer Kate Marjorie F. Villegas, John Peter O. Apostol, Tristan Joshua O. Saet, and Eduarson N. Buatis assigned within seaports and airport of Brgy. Buyabod, Sta. Cruz, Marinduque, Brgy. Masiga, Gasan, Marinduque regular monitoring of possible wildlife transportation. Likewise, conducted coordination within Philippine Port Authority (PPA), Terminal Port Manager (TMO) within the area.
- On August 16-17, 2022, Forest Ranger Florante G. Fandialan, Jr., Forest Protection Officers, John Peter O. Apostol and FPO Tristan Joshua O. Saet, assigned within seaport of Balanacan at Brgy. Balanacan, Mogpog, Marinduque conducted regular monitoring of possible wildlife transportation. Likewise, conducted coordination within Philippine Port Authority (PPA), Terminal Port Manager (TMO) within the area.

Please be informed that Marinduque Airport within Barangay Cawit, Gasan Marinduque were temporarily closed due to pandemic and their operations were temporarily stop.

As to wildlife and forest products/minerals, no transportation was monitored during the said period.

Further, informational materials such as flyers regarding Republic Act No. 9147 "Wildlife Conservation and Protection Act" and other DENR forestry laws, rules and regulations were also distributed as part of public awareness. Hanging of tarpaulin was also displayed inside the premises of port.

August 18, 2022

**MARINDUQUE** 

In compliance with target activities of Monitoring and Enforcement Section and PENRO Special Order No. 010 dated February 07, 2022 relative on the creation of teams of Wildlife Traffic Monitoring Unit to monitor the seaport and airport within the province of Marinduque.

Please be informed that on August 8 to 12, 2022, the Monitoring and Enforcement personnel conducted monitoring at seaport of Barangay Dos, Gasan, Marinduque. The undersigned monitored the passenger boat scheduled for departure from Gasan, Marinduqe to Pinamalayan, Mindoro for possible transport of wildlife species and forest products.

Moreover, on August 16 to 17, 2022, the undersigned personnel coordinated with LGU of Balanacan, Philippine National Police- Maritime Group and Philippine Ports Authority (PPA) personnel, relative to the monitoring in the port of Balanacan. The team discussed the activities and functions of Wildlife Traffic Monitoring Unit (WTMU). Be informed further, the team also coordinated with the LGU of Buyabod, Sta. Cruz and distributed posters Re: Presidential Decree 705 "Revised Forestry Code of the Philippines" and Republic Act No. 9175 "Chainsaw Act of 2002" for their information. After the coordination, the team proceeded to Buyabod port and coordinated with the staff of Philippine Ports Authority -Terminal Management Office (TMO) of Sta. Cruz. The undersigned conducted monitoring of the arrival and departure of passenger boats from Maniwaya, Polo and Mompong Islands and also to Quezon Province. At Barangay Masiga, Gasan, domestic flight in Marinduque Airport is temporarily ceased while in Barangay Cawit, only cargo vessel loaded with cement berthed in Cawit port.

During the time of monitoring, no illegal transport of wildlife species and forest products were monitored in the said ports.

In view hereof, continuous monitoring at the said seaports and airport is hereby recommended to prevent any illegal wildlife trade and transport of forest products.











