The occurrence of the COVID-19 pandemic has limited the conduct of some field-based activities, including caving, for more than a year. In order to maintain the skills and knowledge of DENR personnel in performing cave-related activities especially those that require rope works, the Biodiversity Management Bureau will be conducting a refresher training on Single Rope Technique (SRT) Level 1 for Luzon Cluster which will be held on **23-30 October 2022** (inclusive of travel time) in Nueva Ecija. To ensure trainers will be able to closely supervise the participants during the practical exercises, the training will be divided into two (2) batches: The first batch will be conducted on 24-26 October 2022 to be participated in by representatives from Regions 1, 2, 3, CAR and BMB, while the second batch from Regions 4A, 4B, 5 and NCR will be on 27-29 October 2022.

For the practical exercises, each participant is required to bring the following caving equipment which was provided to the Regions last 2018:

- 1. Caving seat harness with central mallion or equivalent central connector
- 2. Chest harness
- 3. Bobbin descender with attachment and braking carabiner
- 4. Chest ascender
- 5. Hand ascender with foot loop and attachments including safety line
- 6. Cow's tail including carabiners adjusted to user's body
- 7. Basic Caving Personal Protective Equipment
 - a. Caving helmet
 - b. Headlamp
 - c. Gloves
 - d. Knee pads
 - e. Proper clothes and footwear for caving
