Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated August 25, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel on May 28, 2020 at around 2:06 P.M. while conducting an operation on anti-illegal forest activities in Barangay Sandoval, Roxas, Palawan.

The team apprehended the abandoned 116 pieces of Ipil logs with corresponding volume of 13.58 cubic meters with estimated fair market value of Php60,000.00. The subject Ipil logs were hauled to CENRO Compound for safekeeping purposes under the custody of Forester I Marces C. Lasangen.

Three (3) notices to the public were posted in different public places on July 28, 2021 for August 06, 2021 hearing, August 09, 2021 for August 16, 2021 hearing and August 17, 2021 August 24, 2021 hearing in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended Ipil logs.



Submitted is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel on May 28, 2020 at around 02:06 P.M. while conducting an operation on anti-illegal forest activities in Barangay Sandoval, Roxas, Palawan in collaboration with other Patrol Sectors. The subject forest products were hauled to this Office compound for safekeeping under the custody of Forester I Marces C. Lasangen.

II. NOTICE OF HEARING

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, Item No. 03, posting of Notice to the Public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this Office at the Barangay Hall of the concerned Barangay, Bulletin Board of the Sanguniang Bayan ng Roxas and at the Receiving area of this Office.

Further, in compliance with the memorandum dated June 08, 2022 to conduct administrative hearing inviting Mr. Butchoy Rios to clarify the allegations. This Office issued two (2) Notice of Hearing to Mr. Rios, a resident of Barangay Bancao-bancao, Puerto Princesa City scheduled on July 12, 2022 and July 26, 2022.



III. EVALUATION

In spite of the notice posted, no claimant has appeared on this Office and despite of the issued Notice of Hearing to Mr. Rios, he did not appear on this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

IV. RECOMMENDATION


In view hereof, it is recommended that the one hundred and sixteen (116) pieces of Ipil logs with equivalent volume of 13.58 cubic meter be forfeited in favor of the government. Moreover, a final Notice of Hearing will be issued to the aforementioned alleged owner to shed light as to why no legal sanction shall be instituted against him in the proper court.

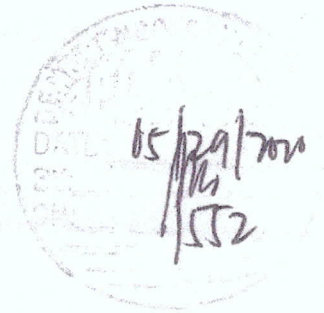

Please be informed that we have our joint operation on other sectors 1, 3, and 4 on three (3) separate apprehensions at Barangay Sandoval, Roxas, Palawan yesterday May 28, 2020 on or about 9:00 o'clock in the morning. First was a Gmelina lumbers loaded on a topdown tricycle-TMX 155 with plate No. XT 4867 driven by certain **Mr. John Mark Dadule** with a total volume of 161.3 bd. feet and shall be deliver to New Barbacan (RETAC) upon the order of certain Mr. Randy Salazar of said Barangay, we had apprehended said specie due to no legal papers or no transport document. Second, about 9:30 instant in the morning another top down HONDA CV 125 with Temporary plate number 0403-0049462 encountered/pass-through in front Barangay Hall upon our coordination with Barangay Captain thereat with our (CENRO) Community Environment and Natural Resources Officer, we investigated the driver in person of **Mr. Jhonny Conde** as to whether or not he has a lawful authority to cut or transport trees or poles but he said he has none so we issued an apprehension receipt. Third, we proceed to Sitio Caibulo of same Barangay regarding the spotted stockpiled of ipil logs and post by our CENR Officer during her NGP site visit along the road going to water district of Sandoval and then we hauled the said scattered number of ipil logs.

Further, we have also requested a Philippine National Police (PNP) Palawan Police Provincial Office Second Palawan Provincial Mobile Force company 2nd Maneuver Platoon Barangay San Nicolas, Roxas, Palawan to escort/assist us in the apprehension and hauling of said illegally gathered ipil logs because, accordingly the illegal gatherers are have their armed for their owned protection against us in case of apprehension. As per our information gathered to the nearby residences thereat the illegally gathered ipil species were allegedly owned by Certain **Mr. alias BUTSOY RIOS** a resident of Puerto Princesa city and they were delivered to Barangay III, Roxas, Palawan and finally, we have counted and scaled a total of 116 pieces with a total volume

of 13.58 cubic meters, also we had posted a Notice of Apprehension to the site from whom ever to claim and shall bring their legal documents if any to the CENRO Office.
