Per Memorandum dated February 22, 2021, this Office requested for clarification on the Order of Investigation dated September 29, 2020 issued by then RED Maria Lourdes G. Ferrer, CESO IV whether this Office has jurisdiction to investigate titled properties considering that the cancellation/reversion of titles prayed for by the petitioners is within the jurisdiction of the Honorable Court.

In a Memorandum dated July 6, 2022 from the Regional Executive Director, it was informed that the DENR has jurisdiction to investigate petitions involving registered patents and titled properties as provided for under Chapter III of DAO 2016-31.

In this regard, considering that aside from the abovementioned case for investigation, there are also numerous land cases being forwarded to this Office for investigation, hence, may we respectfully request that a corresponding fund be downloaded to this Office purposely to cover the expenses to be incurred regarding the said investigation and other related cases.
