It is noted that that the above mentioned RFPs are not registered yet in the Registry of Deeds for the Province of Palawan per letter dated October 27, 2017 of Register of Deeds II Atty. Maricar O. Misa-Tan.

Chapter II of DAO 2016-31 provides the procedure in the resolution of claims and conflicts involving unpatented or **unregistered lands**. All land claims and conflicts over unregistered and/or unpatented lands shall be commenced by filing a verified protest by the claimant, aggrieved party or his/her duly authorized representative with a special power of attorney against another party.¹


Thus, the Protests are referred back to the CENRO for the determination whether the Protests are sufficient in form and in substance, and transmit the same to the PENRO for the issuance of Orders of Investigation, and observe the procedure laid down in Chapter II of DAO 2016-31.

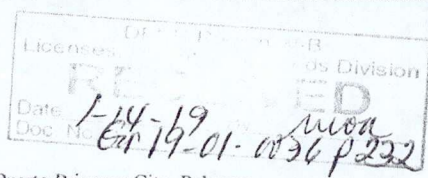
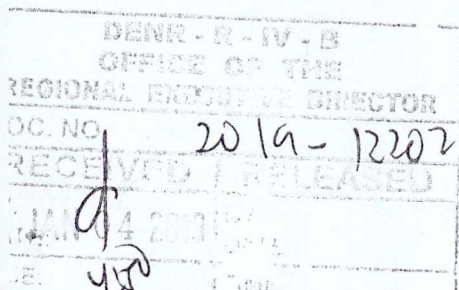


