SUBJECT : INVESTIGATION ON THE ALLEGED ILLEGAL GOLD MINING OF MR. RONNIE ALEJO IN CELIS COMPOUND, SITIO APLAYA, BARANGAY SUMAGUI, BANSUD, ORIENTAL MINDORO

Pursuant to Amended Travel Order No. 402, the undersigned together with Ms. Rosalie Bunguin - MENRO (Municipal Environment and Natural Resources Officer) Staff and Mr. John Luis Sanchez – Agricultural Technologist of Bansud, conducted the above subject on 05 September 2022 in Celis Compound, Sitio Aplaya, Barangay Sumagui, Bansud, Oriental Mindoro.

BACKGROUND INFORMATION

The undertaking was conducted in response to the Memorandum dated 22 August 2022 from the Mines and Geosciences Bureau (MGB) – MIMAROPA Region received by this office on 26 August 2022 forwarding a copy of the complaint text message from an anonymous sender received on 22 August 2022 by the DENR Action Center/Hotline Citizens Complaint with Reference Code Number ACK20220822-01.

In the complaint text message, the anonymous sender expressed her concern on the alleged illegal gold mining activity of Mr. Ronnie Alejo at Celis Compound, Sitio Aplaya, Bansud, Oriental Mindoro. It was mentioned that Mr. Ronnie Alejo gathered people to excavate deep holes in search of gold. It was further stated that flooding has begun in the area.

The investigation aims to validate the veracity of the complaint and to check whether there is a violation of RA 7942 otherwise known as the Philippine Mining Act of 1995.

FINDINGS AND OBSERVATIONS


1. The reported area is located at Celis Compound, Sitio Aplaya, Barangay Sumagui, Bansud, Oriental Mindoro.
2. The site is accessible by means of any land-type vehicle via the nautical highway of Bansud, Oriental Mindoro. From the nautical highway, the subject area is accessible by an approximately one (1) kilometer vehicle ride on an unpaved road access along Salamia Blvd.
3. During the investigation, approximately 1.2 by 1.2 meters wide and seven (7) feet deep excavation with wooden planks for support and a piggery containing eighteen (18) pigs were noted in the area.
4. There is no on-going mining operation during the investigation.

5. The extracted soil materials were stockpiled beside the excavated area. Likewise, there is no evidence of illegal disposition of the soil material.
6. According to a local resident near the vicinity, Mrs. Lina Magallanes, the area has long been a piggery and the excavated hole is for the biogas production project of Mr. Ronnie Alejo.
7. She further mentioned that the reported area is a private lot owned by Mr. Ronnie Alejo and that no flooding is being experienced in the area.
8. Mr. Ronnie Alejo confirmed that he owned the private lot, and likewise, confirmed that the excavated hole was intended for the biogas production project from pig manures.
9. According to Mr. Alejo, the said project started three (3) months ago and is not continuous due to financial constraint.
10. Moreover, the area is a piggery and the pigs contained at the moment will soon be increased to one hundred (100) heads.
11. In addition, the pigs will be equally distributed to selected poor families for his proposed foundation.
12. He then stipulated that flooding rarely occurs in the area and if flooding does occur, no nearby residents will be affected since it is a private lot.
13. Being in a titled land property, Mr. Ronnie Alejo, the landowner, did not allow photo documentation during inspection.

COMMENTS AND RECOMMENDATION

1. Based on the field observations, no illegal gold mining is being conducted in the area. Hence, no violation of RA 7942 otherwise known as the Philippine Mining Act of 1995.
2. The area should be visited by Environmental and Management Bureau (EMB) to check whether Mr. Ronnie Alejo needs to secure necessary permits for the piggery and proposed biogas production project.

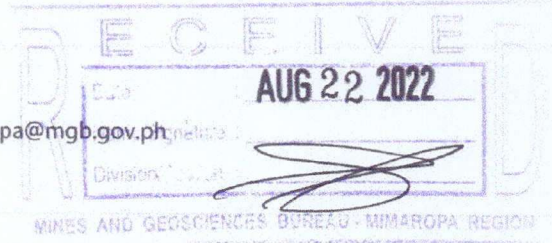
