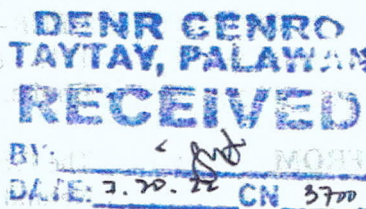

Respectfully submitting is the report on the conducted monitoring of CBFM-CARP 2017 accomplishment for the 2nd quarter of Bato Multi-Purpose Cooperative (BMPC) on June 22, 2022 at Barangay Bato, Taytay, Palawan.

The activity disclosed the monitoring of the CBFM-CARP project awarded to the BMPC located at Barangay Bato, Taytay, Palawan which findings and observations are hereby enumerated as follows:

1. That pursuant to the Executive Order No. 263 adopting Community-Based Forest Management Program (CBFM) as national strategy to ensure the sustainable development of the country's forestland, gave a positive response to address poverty and ensure sustainable management of resources. This was strengthened by the issuance of Executive Order No. 318 known as "Sustainable Forest Management", Executive Order No. 606 known as "Sustainable Upland Development" which anchoring on food, wood and non-wood security and economic productivity. Further enhanced with Executive Order No. 616 known as "The Creation of the Anti-hunger Task Force" to address hunger both on the aspect of supply and demand for food for the upland dwellers, in particular.
2. The Bato Multi-Purpose Cooperative (BMPC) in Barangay Bato which is one of the POs of the said barangay has awarded with the CBFMA on December 27, 2002 to December 27, 2027 with CBFMA No. RIV-PAL-CBFMA-2002-32 with a total area of 1,998 hectares.
3. In 2017, the aforesaid PO had acquired the CBFM-CARP project titled "Forest and Fruit Trees with Bamboo Plantation Project" wherein different commodities had been established in 25 hectares such as Bamboo, Gmelina, Durian, Rambutan, Cacao, Calamansi, Guyabano, Dragon fruits, Banana intercropped with pineapple and vegetable crops.

4. That the said PO had already completed the said project in November 2018 wherein they established the forest and fruit trees in a total area of 28 hectares based on the Work and Financial Plan of the project (please see attached map) while a one (1) hectare that has been allotted for vegetable crops was established outside CBFM area for it was distributed to the members to prepare their own vegetable plot/ backyard garden.
5. That on June 22, 2022, the CBFM Unit Staff conducted the monitoring for the 2nd quarter of the said project particularly the maintenance and protection of some of the commodities such as Durian, Banana and Pineapple, Marcotted Calamansi, Cacao, Bamboo, Gmelina and Dragon fruits nursery.

During monitoring, the issues and concerns observed are the following, to wit:

- Some plantations are not maintained by the beneficiaries.
- Some of the commodities that planned by the PO to be replaced which were affected by the summer season had not yet planted.
- Commodities affected by the installed steel post of NAPOCOR has not yet replaced.

In view of the above observations, the following are being recommended, to wit:

- The beneficiaries should make a way to maintain their plantations.
- The PO should have to conduct the planting activity while it is rainy season.
- The PO should make strategies on how to maintain their CARP areas (i.e. bayanihan)
- The PO should communicate the management of NAPOCOR as per instruction of the Office for the replacement of the affected commodities.

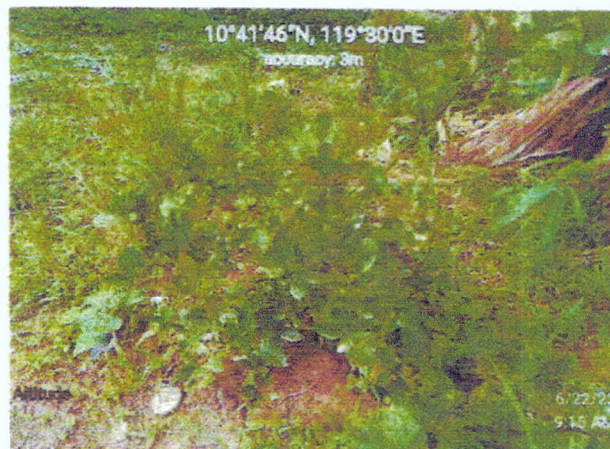



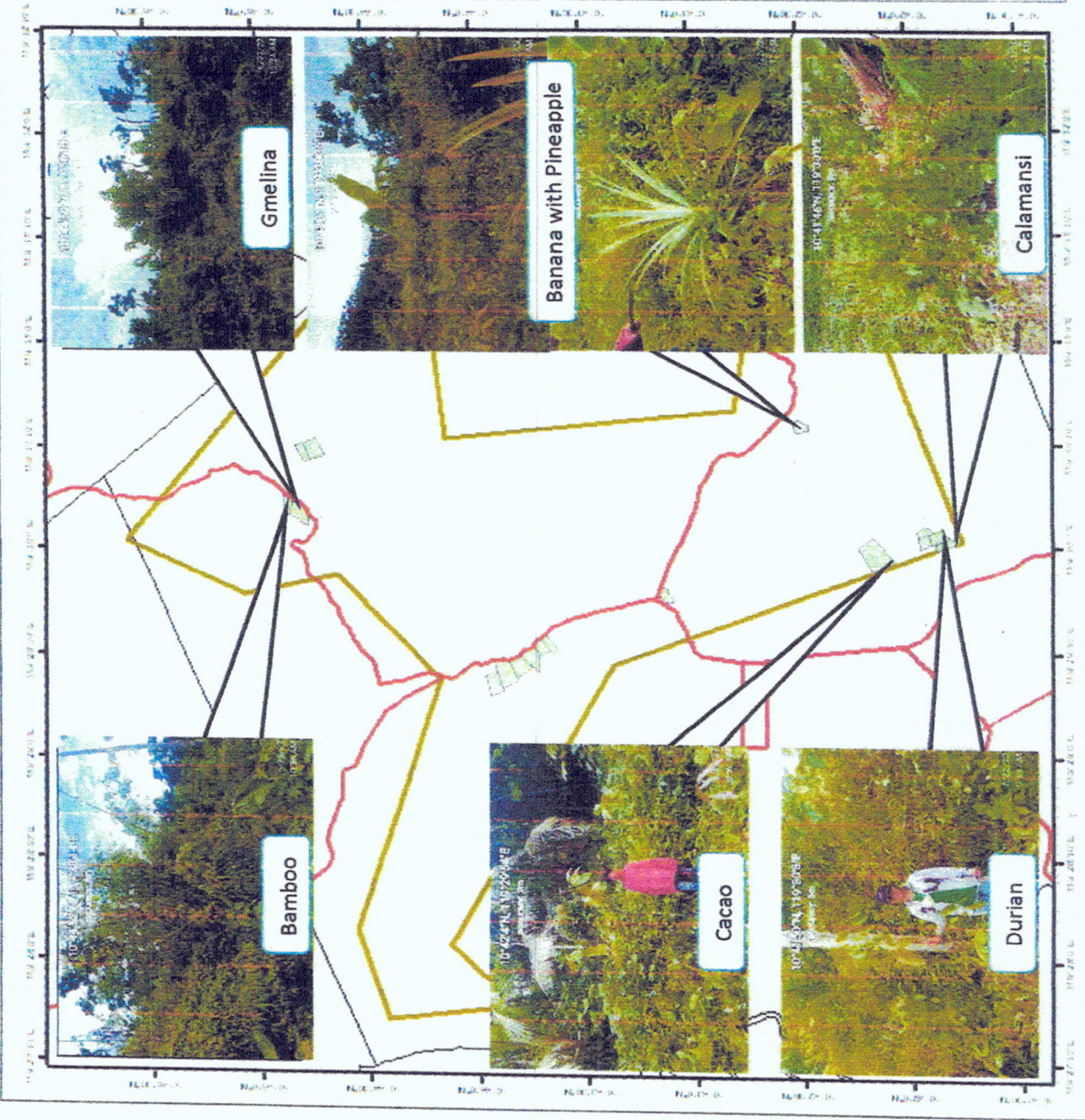
