Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated August 25, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel (Composite Team) on June 30, 2022 at around 1:14 P.M. in response to the received information regarding the stack of lumbers in Barangay Minara, Roxas, Palawan.

The team apprehended the abandoned 15 pieces of Ipil and Putian lumbers with corresponding volume of 174.10 board feet with estimated fair market value of Php16,010.00. The subject lumbers were hauled to CENRO Compound for safekeeping purposes under the custody of Forest Technician II April N. Baltar.

Three (3) notices to the public were posted in different public places on July 13, 2022 for July 20, 2022 hearing, July 21, 2022 for July 28, 2022 hearing and July 29, 2022 for August 05, 2022 hearing in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended Ipil and Putian lumbers.

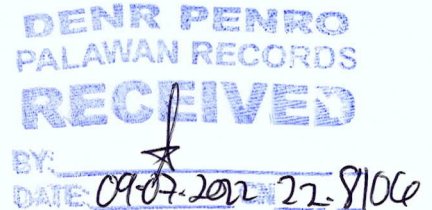

I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel (Composite Team) on June 30, 2022 at around 01:14 P.M. in response to the received information regarding the stack of lumbers in Barangay Minara, Roxas, Palawan. Further, there is no claimant in the area during the time of apprehension hence it was declared abandoned. The forest products were also brought to the CENRO compound of Roxas, Palawan under the custody of Forest Technician II April N. Baltar.

II. NOTICE OF HEARING


III. EVALUATION/RECOMMENDATION

Please be informed that on June 30, 2022, around 12 noon we received an information thru phone call concerning undocumented lumbers seen near the Barangay Road of the Barangay Minara.

In that same date, around 1:20 PM the undersigned together immediately dispatched to verify the veracity of the said information. Upon arrival in the area, the team found thirteen (13) pieces Ipil lumbers and two (2) pieces Potian lumbers scattered in an open vegetable garden area, more or less 5 meters away from the Barangay Road of the above-said Barangay.

During the conduct of further investigation regarding the owner of the said lumbers to the nearby houses and Barangay Kagawad Arnulfo Villanueva who arrived in the area during that time of apprehension, accordingly, they don't have any idea on the owner of the lumbers. Further, they also added that the owner of the area where the lumbers is found was already dead.

The team apprehended the above-mentioned lumbers due to absence of claimant/owner the said lumbers turned abandoned. All the apprehended lumbers (*13 pieces Ipil lumbers and 2 pieces Potian lumbers*) were hauled and brought to the DENR CENRO Roxas compound located in Barangay III, Roxas, Palawan for safekeeping and proper disposition.

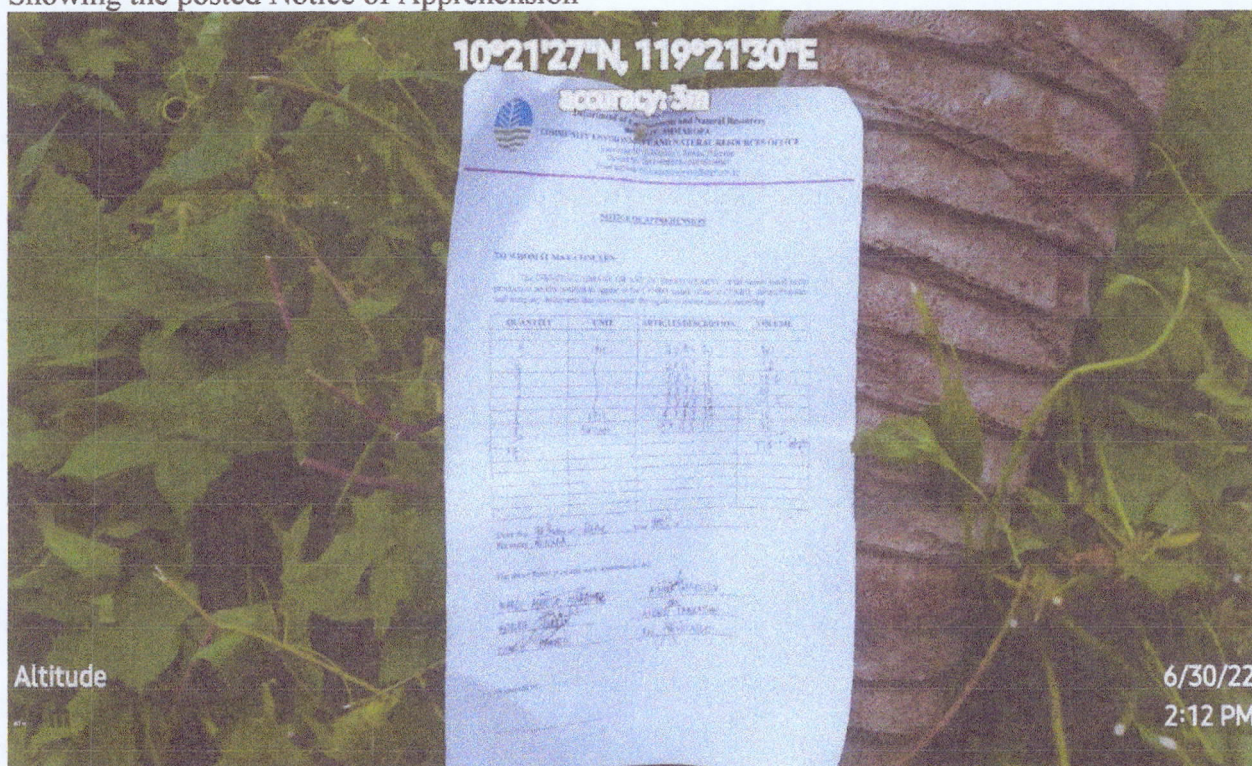
