

Respectfully submitted is the memorandum dated August 8, 2022 of LMO II Elvie G. Base regarding the above subject. The meeting was a venue to discuss the issues and concerns pertaining to the identification of relocation areas for the affected residents in eight (8) barangays of the municipality namely Villa Libertad, Pasadeña, Teneguibanm Sibaltan, Manlag, Bagong Bayan, Aberawan and Bebeladan, the barangays covered by the implementation of the Green Economy Model (GEM) project in El Nido.

As discussed, the LGU is considering titled land at Sitio Yokoton, Barangay Bucana and the area of Fernandez Family in Barangay Pasadeña which is covered by an expired grazing land permit. However, issues were identified along the processing of documents which impeded the negation process.

Consequently, this Office is still extending its assistance to the said LGU for the identification of the relocation area proposed for expansion to form part of our accomplishments to the GEM project of the municipality.

This also serves as our Mean of Verifications (MoV) to the target on the meetings attended under Top Level Management for CY 2022.

Respectfully submitting is the above subject as Means of Verification of the Information, Education and Communication (IEC) of Green Economy Model (GEM) and of Regulation and Permitting Section under continuing activities of GEM for CY 2022.

Please be informed that undersigned with the Chief of Regulation and Permitting Section attended the said meeting held at the Municipal Hall of El Nido, Palawan with the Provincial Environment and Natural Resources Officer and Community Environment and Natural Resources Officer to tackle ENR issues and concern within El Nido Managed Resource Protected Area. One of the issue raised was the common worry of the community if they will be displaced from their current abode.

**Relocation Area**

This was the common concern of the residents of the eight (8) barangays namely Villa Libertad, Pasadeña, Teneguiban, Sibaltan, Manlag, Bagong Bayan, Aberawan and Bebeladan, El Nido, Palawan that will be affected by the implementation of Green Economy Model, rehabilitation and protection of prime ecotourism destination in El Nido, Palawan.

To address this concern, the cooperation of the agency (DENR) and of the Local Government Unit is needed in finding a place to relocate the affected residents. RPS Chief and IEC team member inquired to LGU if they already have found an area possible for relocation so that the agency could extend its service offered on Public Land Survey (PLS) and titling.

According to Municipal Administrator, they are considering the titled land at Sitio Yokoton, Barangay Bucana, El Nido, Palawan to become relocation site. But there is an issue that impede the negotiation. Hence, the LGU is still looking for another area such as the grazing land with expired permit of Fernandez family in Barangay Pasadeña.

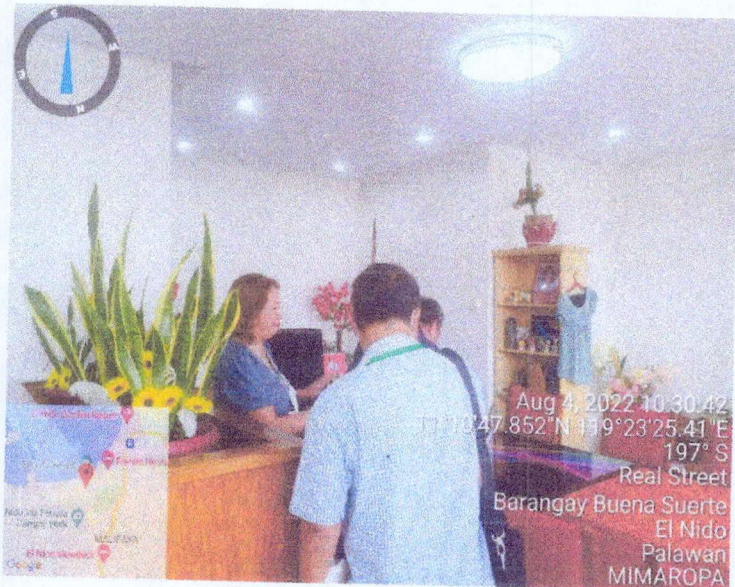
The identification of relocation area is proposal for expansion; to have potential lots for titling in the coming years if the Office can assist the LGU in public land survey.


