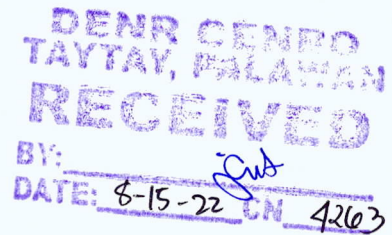

On August 12, 2022, the undersigned apprehended a dump truck loaded with illegally sourced rock boulders in So. Monte Vista, Bgy. Poblacion, Taytay, Palawan.

**Background Information**

On August 12, 2022, a truck loaded with rock boulders passed the DENR – CENRO Taytay Forest Product Monitoring Station 1 (FPMS1). The undersigned, upon checking that the truck was loaded with aggregates proceeded to apprehend the said truck and investigate if the said truck have the necessary transport permit.

As Mines and Geoscience Bureau personnel and a Deputized Environment and Natural Resources Officer for mines, the undersigned is authorized to investigate illegal mining activity and cause the confiscation/ seizure of the minerals/ mineral products and the tools, equipment & conveyance used in the commission of the offense in favor of the Government pursuant to Par. 2f, Sec. 7 of DAO 2010-21.

**Purpose and Scope**

The investigation aims to validate the legality of the transport activity and to conduct necessary action/s to address the issue. The investigation includes interview with concerned individuals, ocular inspection of the area and identification of the party responsible for the activity.

**Findings and Observation**

1. The dump truck was apprehended in So. Monte Vista, Bgy. Poblacion, Taytay, Palawan. Based on the Global Positioning System (GPS) reading acquired by Timestamp Camera, the location can be defined by the following coordinates: 10°48'54.18" north latitude and 119°29'54.24" east longitude.

2. On 12 February 2022, the undersigned apprehended a white 10-wheeler HOWO dump truck with plate number **NEM 3393** owned by **Panaad Construction**. (**Photo 1 – 2**)
3. Upon inspection, it was found out that the truck was loaded with boulder sized rock. (**Photo 3**)
4. The undersigned then asked the driver, Mr. Raul Bucog if they hold any transport permit for the said boulders. Mr. Bucog then presents a Special Delivery Receipt (SDR). Upon inspection of the receipt, the receipt lacks the necessary details like the name of permittee and permit number. Thus, the said SDR cannot be used as permit to transport the boulder materials. (**See attached SDR**)
5. Mr. Bucog also discloses that they sourced the rock boulders in So. Barok, Bgy. Cataban, Taytay, Palawan and will be used in riprapping of a section of road in Bgy. New Guinlo, Taytay, Palawan. As per the Provincial Mining Regulator Board of Palawan, there is currently no active quarry permittee in the Municipality of Taytay.
6. Upon verification that the above-mentioned transport of boulder materials does not have any legal mining and transport permits. It can be considered as *prima facie* evidence of illegal mining pursuant to **Republic Act No. 7942 (Philippine Mining Act of 1995)** and **DENR Administrative Order No. 2010-21**. This is enough cause for the confiscation of materials being transported, the tools, equipment utilized and the vehicle containing the same.
7. The undersigned, as a Deputized Environment and Natural Resource Officer, seized the minerals and the truck was secured. The truck was then brought to the FPMSI for safe keeping with Forest Protection Officers Gilbert Angeles and Marlon Paulo acting as witnesses and custodian of the seized truck. (**Photo 4 & 6**)
8. On 14 August 2022, the undersigned had a dialogue with Eng. Joey Galang. He said that they were not informed on the technicalities of the special delivery receipt. He said that they thought that if they produced an SDR, they were already permitted to transport quarry materials.
9. He also added that he only contacted a certain Mr. Rommel to process the SDR copies for the transport of rock boulders.
10. He further narrated that the Bgy. Captain of Bgy. Cataban, Hon. Jon Tumampil, also permitted them to haul the rock boulders because it was for a dredging activity.
11. The undersigned then explained to Eng. Galang that an SDR will only be used in the utilization of stockpiled quarry materials from an area with an expired quarry permit given that the stockpiled quarry materials were extracted or stocked when the quarry permit was still active.
12. The undersigned also explained that Captain Tumampil does not have authority to permit quarrying activities in the area. Also dredging activities still needs a dredging



permit from the Department of Public Works and Highways pursuant to DPWH Joint Memorandum Circular (JMC) No. 01 Series of 2019.

### **Comments and Recommendations**


1. Based on the field findings, Panaad Construction doesn't have any legal personality to transport or extract earth materials without any delivery receipt or any supporting legal documents pursuant to **Par. 1, Sec. 117, DAO 2010-21**. The absence of any of the foregoing documents shall be considered prima facie evidence of **illegal mining** and shall cause the confiscation/ seizure of the minerals/ mineral products and the tools, equipment & conveyance used in the commission of the offense in favor of the Government, subject to further investigation.
2. Panaad Construction was also found to be in violation of **Section 103** of the **Republic Act No. 7942**, otherwise known as **the Philippine Mining Act of 1995**, which provides that:

*"Section 103. **Theft of Minerals.** - Any person extracting minerals and disposing the same without a mining agreement, lease, permit, license, or steals minerals or ores or the products thereof from mines or mills or processing plants shall, upon conviction, be imprisoned from six (6) months to six (6) years or pay a fine from Ten thousand pesos (P10,000.00) to Twenty thousand pesos (P20,000.00), or both, at the discretion of the appropriate court. In addition, he shall be liable to pay damages and compensation for the minerals removed, extracted, and disposed of. In the case of associations, partnerships, or corporations, the president and each of the directors thereof shall be responsible for the acts committed by such association, corporation, or partnership"*

3. A **Seizure Receipt** was then given to Mr. Raul Bucog, driver of the apprehended truck. (See attached seizure receipt)
4. Panaad Construction is advised to immediately *cease and desist* from further conducting sand and gravel extraction operation in the area without the necessary mining permit.  
  
A **Cease and Desist Order** will be issued by this office to affect the same.
5. It is also recommended that this case be turned over to the Palawan Provincial Mining Regulatory Board (PMRB) to impose applicable penalty in accordance to their existing rules and regulation.
6. Furthermore, the PMRB is also recommended to trace and investigate the source of the SDRs given and being used by contractors to extract and haul aggregates from an area without any valid or active quarry/mining permits.

7. A separate investigation is recommended to investigate the source area in So. Barok, Bgy. Cataban, Taytay, Palawan. The last time the undersigned visited the area, a No Trespassing signed was seen preventing the investigation of the area.
8. Hon. Jon Tumampil is also recommended to explain his participation on the illegal quarrying in his jurisdiction.
9. Regular monitoring in the area is hereby recommended to stop any extraction activity in the subject area.

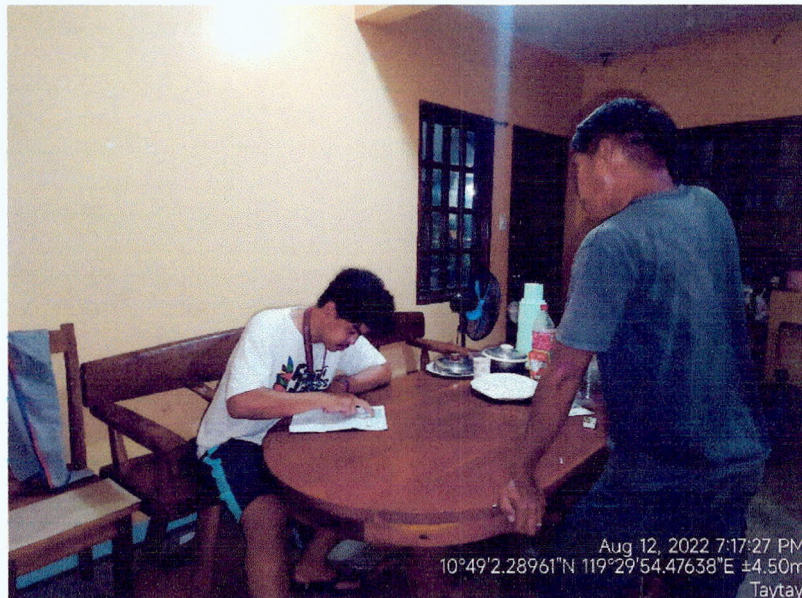
