In compliance with the provisions of DENR Administrative Order No. 97-32 [DAO 97-32], **Administrative Adjudication Proceedings** relative to the above-cited subject were scheduled by the undersigned hearing officer on **11 August 2022** and **19 August 2022** at DENR-CENRO Socorro, Brgy. Pasi II, Socorro, Oriental Mindoro.

## ANTECEDENT FACTS

The apprehending officers in this proceeding are **PMSg Lester S. Lusterio** and **PSSg Eingelbert E. Gonzales** of Victoria Municipal Station [Victoria MPS] while the respondents involved are **Mr. Domingo Sanchez Lavarez**, also known as "Domeng", and **two (2) unidentified persons**, all residents of Brgy. Loyal, Victoria.

Both parties failed to attend the scheduled confiscation hearings despite first and second notices.<sup>1</sup> In lieu thereof, the apprehending officers submitted their "Pinagsamang Sinumpaang Salaysay" along with the investigation records of the Victoria MPS.<sup>2</sup> However, similar to the unidentified respondents, Mr. Lavarez's whereabouts remained unknown as supported by the "Pagpapatunay" issued by Hon. Mark Anthony M. Ganio, Barangay Captain of Loyal, Victoria.<sup>3</sup>

In line with this, the narration below and the corresponding recommendation of the hearing officer, are based on the relevant documents and testimonies gathered from the apprehending officers and DENR-CENRO personnel concerned.

On 18 June 2022 at around 4:00 o'clock in the afternoon, the apprehending officers received an information about an alleged slicing/sawing of woods or lumbers at Sitio Buenavista, Brgy. Loyal, Victoria. They coordinated with Captain Ganio who accompanied them in order to confirm the information.

While on the way to Sitio Buenavista at around 7:00 o'clock in the evening, they have chanced upon three (3) men in the act of pulling lumbers with the use of rope. Captain Ganio identified one of them as respondent Lavarez. The apprehending officers tried to approach the said men to ask for the necessary permit/s relative thereto but they were able to escape immediately. The former did not pursue the latter due to the danger brought by the dark surroundings and presence of CPP/NPA in the area. Accordingly, the officers transported the apprehended lumbers to Victoria MPS and PSSg Mervin G. Cong promptly emailed a Letter Request to DENR-CENRO Socorro for the scaling of the lumbers.

On 20 June 2022 at around 8:30 in the morning, Forester Kevin L. Corpuz and Forest Ranger Julius V. Fontanilla of DENR-CENRO Socorro went to Victoria MPS to scale, mark, and receive the apprehended lumbers.

Seizure Order and Seizure Receipt No. 2022-12 were issued by the hearing officer to officially take custody of the said forest products pending the administrative procedure with details, to wit:<sup>4</sup>

## RECOMMENDATION

Based on the foregoing, the apprehended forest products were gathered and transported without the required permits.

**WHEREFORE**, it is respectfully recommended that 11 pieces of Lauan lumber with an aggregate volume of 151.67 board feet and 13 pieces of Taluto lumber with an aggregate volume of 208 board feet **be confiscated in favor of the Government of the Philippines and such be disposed of in accordance with the existing laws and procedures**

1. What : Violation of PD 705 (Illegal Logging)
2. Where : Sitio Buenavista, Brgy. Loyal, Victoria, Oriental Mindoro
3. When : June 18, 2022 at about 7:00 PM
4. Who : Domingo Sanchez Lavarez aka "DOMING", 37 years old, male, married, abd two (2) unidentified persons, all resident of Brgy. Loyal, Victoria Oriental (all at-large)
5. How: That on about 07:00 PM of the same date, Intel PNCO of this station led by PMSg Lesther S Lusterio, C, Intel together with Brgy Captain Marck Anthony M Ganio of Barangay Loyal of this municipality in coordination with DENR-CENRO while conducting Anti-Illegal Logging at Brgy Loyal, Victoria, Oriental Mindoro, upon reaching Sitio Buenavista of said barangay they chance to encounter an unidentified persons pulling illegally sawn lumbers used of ropes and they tried to arrest the suspects but they immediately run to the forested area of the said barangay toward to unknown directions and eluded arrest. Afterward, personnel of this station seized and recovered illegally sawn lumbers (White/ Red Lawaan and Paper Tree) with estimated more or less Three Hundred (300) board feet with estimated market value amounting to more or less Php 12,000.00. That upon verification of the suspects to Brgy. Captain Mark Anthony M Ganio, he proved that one of the said suspects was a legitimate resident of Barangay Loyal of this municipality and identified as Domingo Sanchez Lavarez aka "DOMING" (at-large). A hot pursuit operation was conducted by this Office for the possible apprehension of the said suspects.
6. Moreover, the recovered/confiscated illegally sawn lumbers will be turned over to DENR-CENRO for scaling and proper disposition and a case of Violation of PD 705 will be prepared to file against the suspects at Oriental Mindoro Provincial Prosecutors Office, Calapan, City Oriental Mindoro.
