

GSS-1410 Puerto Princesa Group Settlement Survey lots technical descriptions and corresponding land titles refer to that reference point, but it cannot be located on the ground, which leads to limited accuracy of new surveys, attempts to relocate established boundaries and disputes between land owners.

Knowing the correct location and/or coordinates of that reference point is essential for ensuring reliable and accurate results of geodetic surveys in Bgy. Bacungan.
