EXCERPT FROM THE MINUTES OF THE 9th REGULAR SESSION OF THE SANGGUNIANG BAYAN OF SANTA CRUZ, OCCIDENTAL MINDORO, CALENDAR YEAR 2022 HELD AT THE SANGGUNIANG BAYAN SESSION HALL ON SEPTEMBER 12, 2022.

RESOLUTION No. 2022-036

RESOLUTION EARNESTLY REQUESTING DIRECTOR LORMELYN E. CLAUDIO, REGIONAL EXECUTIVE DIRECTOR, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) MIMAROPA TO PRIORITIZE THE MUNICIPALITY OF SANTA CRUZ, OCCIDENTAL MINDORO FOR THE IMPLEMENTATION OF RAPID LAND TENURE APPRAISAL (RLTA) PROGRAM.

WHEREAS, major residential and agriculture land areas in the municipality are yet declared under its mother title in which the land properties are not legally entitled to owners who are currently possessing it, thus creating burden both to the community and the government;

WHEREAS, Municipality of Santa Cruz ranked last among the municipalities in the Province of Occidental Mindoro in terms of real property tax (RPT) collection due to proper disposition of lands is left unacted;

WHEREAS, through the Rapid Land Tenure Appraisal (RLTA) program of the Department of Environment and Natural Resources (DENR) the land tenure situation in the municipality can be assessed to determine the remaining scope for the acceleration of land titling;

WHEREAS, Rapid Land Tenure Appraisal (RLTA) program is now currently conducting in the Municipality of Abra De Ilog as a pilot municipality in the Province of Occidental Mindoro;

WHEREAS, one of the priority thrusts of the Municipality of Santa Cruz is finding a way through the help and coordination of the national government by giving order for the land titling of the entire municipality being a key factor to increase LGU's real property tax collection which is our big challenge for several decades;

NOW THEREFORE, on joint motion of the Members of the Sangguniang Bayan of Santa Cruz, Occidental Mindoro.

RESOLVED, as it is hereby resolved to request Director Lormelyn E. Claudio, Regional Executive Director, Department of Environment and Natural Resources (DENR) MIMAROPA to prioritize the municipality of Santa Cruz, Occidental Mindoro for the implementation of Rapid Land Tenure Appraisal (RLTA) Program.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned agencies for information, reference and guidance.
