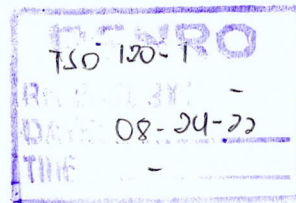
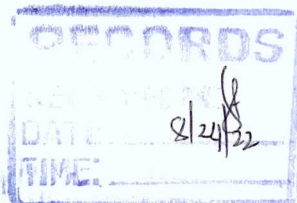

RE: APPREHENSION OF ABANDONED ONE HUNDRED TWENTY TWO (122) PCS. OF ASSORTED LUMBER (77 MALUGAI & 45 NATO SPECIES) WITH DIFFERENT DIMENSIONS HAVING AN AGGREGATE VOLUME OF 2,212.92 BDFT. AT SO. CANWALING, BRGY. RIZAL (LIMLIM), RIZAL, OCCIDENTAL MINDORO ON JULY 26, 2022 AT AROUND 9:17 IN THE MORNING.

RESOLUTION No. 2022-061

This pertains to the apprehension of Abandoned Seventy seven (77) pieces of Malugai and Nato lumbers with a total volume of 2,212.92 bdf. at So. Canwaling, Brgy. Rizal (Limlim), Rizal, Occidental Mindoro on June 26, 2022 at around 9:17 in the morning by the Personnel of Enforcement and Monitoring Section (EMS) DENR- CENRO, San Jose, Occidental Mindoro.

The facts of the subject case are as follows, to wit:

1. That on June 25, 2022 the staff/personnel of Enforcement and Monitoring Section (EMS) of this Office headed by its Chief, Hector S. Aragones Jr. conducted a monitoring and surveillance accordingly in response to a report through a cellphone call from a confidential asset that there was stockpiled of lumber believed to be illegally cut at So. Canwaling, Brgy. Rizal (Limlim), Rizal, Occidental Mindoro ready for transport via So. Gutad, Brgy. Tanyag, Calintaan, Occidental Mindoro.
2. That on July 26, 2022 at around 9:17 in the morning with the continuation of monitoring and surveillance, the team found the reported abandoned lumbers piled and ready for carabao skidding and was identified as Malugai and Nato species. Upon inventory/scaling that was immediately conducted revealed that there were Seventy seven (77) pieces of Malugai and Forty five (45) pieces Nato Lumbers with a volume of 2,212.92 bdf. and without claimant on the time of discovery hence, considered as abandoned. *(Please see attached spot report and geo-tag photos)*

3. That the team apprehended the above-subject lumber and hauled to DENR-CENRO, San Jose Occidental Mindoro, for safekeeping. *(Please see attached spot report and apprehension receipt.)*

4. That the corresponding Apprehension Receipt with CENRO Control No.2022-F455 was issued by the apprehending officer headed by EMS Deputy Chief, Forester I, Jomar B. Serquina *(please see attached apprehension receipt)*

5. That the Seizure Order with CENRO Control Number 2022-F455 was issued by The Seizure Officer, EMS Chief, Forester III, Hector S. Aragones Jr. *(please see attached seizure order)*

6. That a PABATID SA PUBLIKO (Notice to the Public) was posted on July 28, August 04 and 11, 2022 in conspicuous places such as at So. Canwaling, Barangay Rizal (Limlim) and at the Brgy. Hall of Barangay Rizal, Rizal, Occidental Mindoro. *(please see attached Pabatid sa Publiko)*

7. That, No Administrative hearing was made because there was no claimant of the said abandoned forest products even though a Pabatid sa Publiko has been posted on 3 separate dates and at the conspicuous places of the area of concern. (please see attached Pabatid sa Publiko)

The issues to be resolved in this case are as follow;

1. The grounds for apprehension and seizure of the forest products is valid, as the abandoned forest product is not supported with any cutting permit issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 705, May 19, 1975, revising Presidential Decree No. 705 otherwise Known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and republic Act No. 7161, states that;

SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. – Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code

xxx

SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation. – In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

Xxx

Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.

- a. ***ILLEGAL FOREST PRODUCTS*** - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported: (a) without the requisite authorization or permit; or (b) with incomplete required supporting documents 1; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

2. Based in the case at bar, the cutting of forest products without legal documents if proven is a violation of Section 77 of PD 705 as amended by Executive Order No. 277 and Republic Act 7161 thus subject to confiscation.


Wherefore, pursuant to Section 77 and 77-a of PD 705 as amended, section 2 and 7 of DENR Administrative Order No. 97-32, series of 1990 and based on DAO 98-24 (Manual of Approvals) the following are hereby recommended:

1. The **ABANDONED SEVENTY SEVEN (77) PIECES OF MALUGAI AND FORTY FIVE PIECES OF NATO LUMBERS 3"x8"x20', FOUR (4) PIECES; 3"x9"x20', ONE (1)**



Please be informed that on July 25, 2022 the Chief, Enforcement and Monitoring Section Forester III Hector S. Aragones, Jr. received a call from the informant that there was an illegal lumber at So. Canwaling, Brgy. Rizal, Rizal, Occidental Mindoro and ready for transport via So. Gutad, Brgy. Tanyag, Calintaan, Occidental Mindoro. The Enforcement and Monitoring Section team proceeded to the area to conduct monitoring and surveillance to intercept the transport of the said illegal lumber but there was no illegal lumbers passed by. On July 26, 2022, the team conducted patrolling at So. Canwaling, Brgy. Rizal, Rizal, Occidental Mindoro. At 9:17 am, the team found abandoned lumbers filed and ready for Carabao yarding. It was identified that the lumbers were Malugai and Nato. Inventory/scaling were conducted and there were Seventy Seven (77) pieces of Malugai and Forty five (45) pieces Nato lumbers with a total volume of 2,212.92 bdf. The Enforcement and Monitoring Section apprehended abandoned Seventy Seven (77) pieces of Malugai and Forty five (45) pieces Nato lumbers with a total volume of 2,212.92 bdf, apprehension receipt were posted at the area where the lumbers found. Hauling of apprehended lumbers were conducted through Carabao yarding from So. Canwaling, Brgy. Rizal, Rizal, Occidental Mindoro to So. Gutad, Brgy. Tanyag, Calintaan, Occidental Mindoro and Seedling Truck to CENRO San Jose Murtha Station. Apprehended abandoned lumbers were properly safe kept at DENR CENRO San Jose Murtha Station on July 31, 2022.

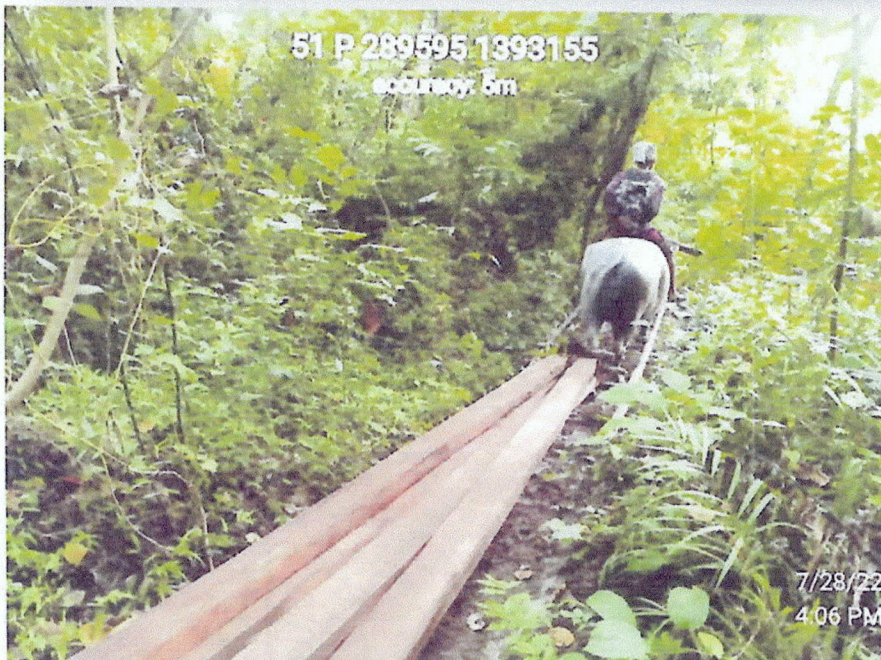


