Respectfully forwarded is the memorandum from CENR Officer Anastacio A. Santos dated September 6, 2022 regarding the above-cited subject.

While conducting an Anti-illegal Logging Operation, the personnel of PNP-MPS Abra de Ilog, Occidental Mindoro accidentally saw a pile of cut sawn lumber inside the compound of Mr, Gadiel Cortuna at So. Humabali, Barangay Armado, Abra de Ilog, Occidental Mindoro. Upon interrogation, Mr. Cortuna was not able to produce any lumber's documentation, hence, the two hundred forty nine (249) board feet of Anabitan lumber were confiscated and turned over to the DENR.

As stated in the Resolution, the case was referred to the Office of the Provincial Prosecutor but later dismissed due to lack of evidence since no search warrant was issued to the respondent at the time of the seizure. As per picture filed by both the complainant and the respondent, it is clear that that the police could not have seen the lumber from the National Road in plain view and they have to enter the premises of the respondent to gain access to the subject lumber which are located behind the house being built within the area.

On the other hand, the Administrative Case was filed against Mr. Cortuna for violation of Secton 77 of PD 705 as amended. On July 19, 2022 the administrative hearing was conducted and the Hearing Officer Forester II Ariston SJ. Ramos recommends the forfeiture of the apprehended forest products in favor of the government.

COMPLETED STAFF WORK REPORT ON THE APPREHENDED UNDOCUMENTED FOREST PRODUCTS, IN VIOLATION OF SECTION 77 OF PD 705 AS AMENDED BY RA 7161 AND DAO 97-32, SERIES OF 1997

I. HISTORY

The case was filed againstMr. Gadiel Cortuna, a resident of Barangay Armado, Abra de Ilog Occidental Mindoro.

That on May 20,2022, on or about 1:40 in the afternoon, during their Anti-Illegal Logging Operations, the Abra de Ilog Municipal Police Station accidentally saw 294 bd ft. of Anabitan species inside Mr. Gadiel Cortuna's compound at So. Humabali, Brgy. Armado, Abra de Ilog Occidental Mindoro

During the apprehension, Mr. Cortuna was asked if he have legal papers that will prove his valid ownership over the subject logs, but he answered in the negative.

The subject logs were confiscated and turned over to the DENR-CENRO Sablayan Coordinating Office at Mamburao Occidental Mindoro.

On May 21, 2022, the accused was brought to the Office of the Provincial Prosecutor at Mamburao, Occidental Mindoro for inquest proceedings. The Associate Provincial Prosecutor recommended that the case underdo a regular preliminary investigation.

On June 1, 2022, The Office of the Provincial Prosecutor dismissed the complaint file against Mr. Gadiel Cortuna for lack of evidence.

On July 19, 2022, the administrative hearing for the above apprehended illegal forest products was held at the DENR-CENRO Sablayan Coordinating Office. EMS Chief Ariston SJ. Ramos facilitated the hearing. The accused was present and was given the chance to explain himself.

OBSERVATION/FACTS

- 1. That during the Anti-Illegal Logging Operations of the Abra de Ilog Municipal Police Station, they apprehended 294 bd ft. of Anabitan species inside Mr. Gadiel Cortuna's compound at So. Humabali, Brgy. Armado, Abra de Ilog Occidental Mindoro.
- 2. That when ask for proper documentation of the said logs, Mr. Cortuna failed to present one.
- 3. That on May 21, 2022, the accused was brought to the Office of the Provincial Prosecutor at Mamburao, Occidental Mindoro for inquest proceedings.
- 4. That on June 1, 2022, the case was dismissed for lack of evidence.
- 5. That as stated by the Associate Provincial Prosecutor's Resolution dated June 1, 2022, the case did not fall under plain view, therefore, any evidence obtained during the apprehension will be inadmissible for any purpose in any proceeding.

6. That in the Administrative hearing conducted on July 19, 2022, Mr. Cortuna appeared and was given the chance to explain himself.

II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that the accused were caught by the Abra de Ilog Municipal Police Station. He was caught in possession of undocumented forest products which is in violation of Section 77 of PD 705 as amended by RA 7161.

Section 77 clearly states that possessing forest products without proper documents or permit from the proper authority is a violation under PD 705.

III. RECOMMENDATION

Based on the above statement of facts and result of the complaint filed, it is hereby recommended that all forest products and chainsaws still be forfeited in favor of the government.

RESOLUTION

For resolution is the complaint of the MUNICIPAL POLICE STATION, ABRA DE ILOG, OCCIDENTAL MINDORO, against GADIEL CORTUNA y VALENTIN of Sitio Humabali, Barangay Armado, Abra de Ilog, Occidental Mindoro, for violation of Sec. 77, PD 705, as amended.

In support thereof are the: 1.) JA of PSSg Michael G. Tacuyo; 2.) JA of PCpl Xander V. Ildefonso; 3.) Turned Over of Confiscated/Seized Items; 4.) Inventory of Confiscated/Seized Items; 5.) Acknowledgment Receipt; and 6.) Pictures.

The instant case was originally referred to this Office for Inquest Proceedings. However, in the resolution issued therefor, and for reasons cited therein, the undersigned recommended that the case undergo a regular preliminary investigation instead, hence the case at bar.

From the police's submissions, it appears that on May 20, 2022 at around 1:40 in the afternoon, elements of the Abra de Ilog Municipal Police Station were conducting Anti-Illegal Logging operation within their jurisdiction, when they accidentally saw a pile of cut sawn lumber of respondent.

When asked for the lumber's documentation, respondent could not produce any, thus he was arrested. The 249 board feet of Anabitan lumbers were confiscated and turned over to the DENR.

In his defense, respondent argued that the lumbers obtained from him are fruit of the poisonous tree, thus inadmissible in evidence in any proceedings in view of the constitutional guarantee enshrined in the Constitution.

He added that the police could not have seen the lumbers from the street, in plain view, as the same were located behind the house being constructed and is covered by a *tolda*. In support thereof, he appended pictures showing the relative position of the house and the supposed location of the lumbers confiscated vis-à-vis the National Road

As the said lumbers were inside his premises, the police's entry therein, unarmed with a search warrant, is in violation of his right against unreasonable searches and seizures.

Witnesses Jover Mateo and Joseph Damiray corroborates the material averments of the respondent.

We resolve to dismiss the instant case.

From the picture filed by the respondent, it is clear that the police could not have seen the lumbers from the National Road – in plain view. The police would have to enter the premises of the respondent to gain access to the lumber which are then behind the house being constructed, and are covered by a *tolda*. It should be noted that the pictures filed by both the complainant and the respondent substantially jives as to the relative position of the questioned lumbers.

It cannot be denied that the police were unarmed with a search warrant at the time of the seizure and the subsequent arrest.

Sec. 2. The right of the people to be secure in their persons, houses, papers, and effects against unreasonable searches and seizures of whatever nature and for any purpose shall be inviolable, and no search warrant or warrant of arrest shall issue except upon probable cause to be determined personally by the judge after examination under oath or affirmation of the complainant and the witnesses he may produce, and particularly describing the place to be searched and the persons or things to be seized.² (Emphasis supplied.)

Sec. 3. (1) x x x

(2) Any evidence obtained in violation of this or the preceding section shall be inadmissible for any purpose in any proceeding.³ (Emphasis supplied.)

The Supreme Court has consistently held that [E]vidence obtained and confiscated on the occasion of such unreasonable searches and seizures are deemed tainted and should be excluded for being the proverbial fruit of a poisonous tree.⁴

Moreover, the record is bereft of any incidents with which the police may anchor their probable cause to enter the respondent's premises, conduct search and arrest his person.

Such being the case, the lumbers confiscated from respondent cannot be used in evidence against him in any proceedings, including the one before us now.

WHEREFORE, premises considered, and for lack of evidence, the instant case is hereby DISMISSED.

The Municipal Police Station, Abra de Ilog, Occidental Mindoro, having custody of the respondent, Gadiel V. Cortuna, is hereby ordered to release his person from their custody, unless held for other lawful causes.
