

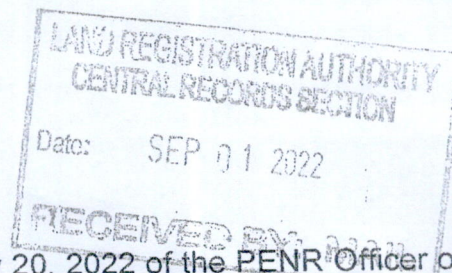




Dear Hon. Administrator,
