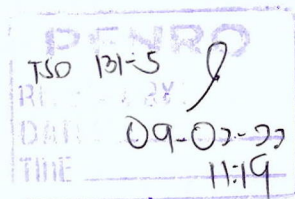

ORDER

In today's hearing via partially remote videoconferencing, Public Prosecutor Warren Wesley M. Malalad, Public Attorney Jeffrey M. Mercado, Ms. Augreth S. Saligumba, Atty. Sancho C. Niedo III (both of the DENR), Pat. Marvin O. Tagupa, and the accused are all present.


The accused was assisted by Atty. Mercado during arraignment. After having explained to him the nature and consequences of his plea and having manifested to have understood the same, accused was arraigned in a language or dialect known and understood by him. He entered a plea of **GUILTY** to unlawful possession of chainsaw under Section 7, Paragraph (1) of R.A. No. 9175. Let his plea be entered in the record.

WHEREFORE, judgment is hereby rendered finding **VICTOR PALOMO y Hermoso, GUILTY** beyond reasonable doubt of Violation of Sec. 7, Par. (1) of R.A. No. 9175 and is hereby sentenced to pay a **fine of Fifteen Thousand Pesos (P15,000.00) with subsidiary imprisonment in case of insolvency.**

The **Oregon chain saw without serial number** color orange and white with marking **VJM-01** and the paraphernalia with marking **VJM-02**, which were seized in connection with this case are declared **confiscated and forfeited** in favor of the government to be disposed of in accordance with law.
