



### BACKGROUND INFORMATION

This Office received a letter dated 04 July 2022, from Ms. Laila M. Agnes, Punong Barangay of Paclolo, Magsaysay, requesting a site assessment of a section of the Caguray River adjacent their barangay. The letter stated that there were problems in the mentioned section of the river, but no further details were provided other than photos of the site included in the letter.

In response to the foregoing, the undersigned, accompanied by Forester Hector S. Aragones, Chief of the Enforcement and Monitoring Section of CENRO San Jose, conducted an investigation into the matter on 11 July 2022. The undertaking included dialogue/interviews with Sangguniang Barangay Members of Paclolo and other parties involved, as well as an ocular inspection of the concerned area.

### FIELD FINDINGS

Presented below are the compiled information and field findings acquired by the undersigned during the undertaking:

1. To determine the scope of the request and complaint, the undersigned first proceeded to the Barangay Hall of Paclolo and interviewed Sangguniang Barangay Members Mr.

Brgy. Labangan, San Jose, Occidental Mindoro Tel. Number (043) 457-0236/(043) 742-6627 Email: cenrosanjose@denr.gov.ph Onofre B. Montilla and Mr. Jerry P. Campo. Punong Barangay Agnes was not around at the time.

The following information were gathered from the above interview:

- There was an alleged dumping of aggregates along the *riverbank* of the mentioned section of the Caguray River, which was said to affect its channel flow.
- The dumping of aggregates for the purpose of planting crops was allegedly initiated/allowed by Ms. Vilma Atienza and Mr. Rolando Balbino, both SB Members from Barangay Purnaga.
- The SB members of Barangay Paclolo are concerned that the said activity will divert river water flow and pose a flood risk in the barangay's low-lying area near the riverbank.
- 2. The undersigned then inspected the reported site. As mentioned above, it is situated along the riverbank of a segment of Caguray River in Barangay Purnaga defined by geographical coordinates 121° 11' 52" East Longitude and 12° 23' 8" North Latitude based on the Global Positioning System (GPS). It is located approximately 10 kilometers aerial distance northeast of Magsaysay Municipal Hall and accessible by any utility vehicles via roadways and thoroughfares from the town proper.
- 3. In an interview, Ms. Atienza and Mr. Balbino revealed that the piled-up aggregates came from a nearby road construction project, and that the riverbank where they were dumped is a titled lot/property owned by a certain Mr. Elias. They stated that the contractors for the said project were unable to find any location to dump the aggregates, so they proposed dumping them on the said lot. (See Photo A-1)

It was confirmed by the Regulation and Permitting Section of this Office that the titled lot/property is owned by a Mr. Welito B. Elias.

- 4. The following were observed during the site inspection:
  - The aggregates were dumped along the riverbank of Caguray River and not within its active channel. (See Photos A-2-3)
  - The site is considered part of the Lourdes-Paclolo reach of Caguray River which
    is characterized by well-defined *point bars* or the accumulation zone of river
    deposits, as well as *cut banks* or areas constantly eroded by running water.
  - The point bar of this segment of the river is situated near the riverbank adjacent to the low-lying areas of Brgy. Paclolo, which is heavily silted with pebble to cobble deposits. On the contrary, the riverbank on the side of Barangay Purnaga, where the dumped aggregates are located, is being continuously eroded by the river. (See Photo A-4)
- Previously a rice field, portions of the said riverbank are now utilized by river quarry operators to stockpile sand and gravel deposits. Some of these stockpiles were noted during the site assessment (See Photo A-5). According to the locals, some of these

materials are being stockpiled and used by private contractors for the road construction project near the area.

However, it was not confirmed whether the above stockpiled aggregates were extracted in the said portion of the river or if they were extracted elsewhere and simply stockpiled near the road construction project.

According to the existing list of Quarry Permit Holders of the PG-Environment and Natural Resources Office (ENRO), there are only two (2) active sand and gravel extraction permits along Caguray River within the jurisdiction of Poblacion, Magsaysay.

### **COMMENTS AND RECOMMENDATIONS**

In view of the foregoing findings, hereunder are the comments and recommendations of the undersigned:

 The stretch of Caguray River is characterized by a meandering morphology with point bars and cut banks which allow lateral migration of the river channel. The point bars are heavily accumulated with predominantly coarse sand to gravel-sized deposits. Because the Lourdes – Paclolo reach of Caguray River is more dynamic than the other segment of the river, consistent deposition and erosion processes occur. As previously stated, well-defined point bars and cut banks were observed in the vicinity of the site.

Erosion takes place at the cut bank along Barangay Purnaga adjacent to the subject area. As a result, scouring of riverbank in the barangay is expected to continue. On the contrary, the heavily silted point bar and river flow direction are to the areas covered by Barangay Paclolo, resulting in a relatively shallow channel that is prone to extensive river overflows/flooding, particularly during rainy season. In addition, the barangay is located at a relatively lower elevation than Purnaga, making it more vulnerable to flooding events.

- 2. To reiterate, the aggregates were dumped along the existing riverbank of Caguray River and not within its channel. Rivers naturally divert their course mainly driven by the combination of bank erosion and point bar deposition over time. Significant changes to the channel flow may not occur as long as the current state of the river and its banks are not disturbed (i.e., no stockpiling or dumping of aggregates within the active river course, and intentional extraction of aggregates along the riverbanks).
- 3. The local government of Barangay Paclolo is also advised to closely monitor the said activity, as well as any other activities near the Caguray River to ensure that the river's current condition is not disturbed or affected.
- 4. Likewise, both the LGUs of Barangays Paclolo and Purnaga should prohibit quarry operators from stockpiling extracted river deposits within the river channel. Moreover, additional vegetation in critical riverbank slopes and floodplain areas can be

introduced to augment appropriate protection measures for potential flood and erosion hazards.



This is in relation to your letter complaint dated 04 July 2022 received by this Office and likewise requesting for a site assessment of a section of Caguray River near your barangay regarding the alleged dumping of aggregates along the said river.

That based on the result of the field investigation conducted by the technical personnel of this Office on July 11 & 13, 2022, it was reported/confirmed that Ms. Vilma Atienza and Mr. Rolando Balbino initiated the dumping of aggregates that came from a nearby road construction project. However, the materials were piled-up *along the existing riverbank*, on a titled lot/property, and not within the active channel of the river. In which they were already advised to refrain from their activities that may result to flooding in the nearby area.

It was accordingly further observed that the heavily silted portion of the river and river flow direction are to the areas covered by Barangay Paclolo, resulting in a relatively shallow channel that is prone to extensive river overflows/flooding, particularly during the rainy season. That rivers naturally divert their course mainly driven by the combination of bank erosion and river deposition over time. Significant changes to channel flow may not occur as long as the current state of the river and its banks are not disturbed (i.e., no stockpiling or dumping of aggregates within the active river course and intentional extraction/quarrying of aggregates along the riverbanks).

In view thereof, the local government of Paclolo is therefore advised to closely monitor the said activity, as well as any other activities near the river to ensure that the present stability of Caguray River is maintained.




