Ito ini-report sa amin ng aming caretaker sa lupa na iyon na si Salvador Lazaro Morante, Sr. Nakalakip dito ang Sinumpaang Salaysay ni Mr. Morante Sr. bilang Annex - D.

4. Na nalaman namin na ang nag-palagay ng muhon na ito ay sa pangunguna ni Mr. Carlito Valdeztamon bilang representante ng Samarinana Multipurpose Cooperative nang hindi naman nag-papaalam sa amin o sa mga anak ko na ayon mahigpit na batas ng pag-quary na dapat ay may Adjacent Lot Owner Consent mula sa may ari ng katabi ng ilog.
5. Na noong August 27, 2021 ay personal akong sumulat patungo sa kay Mr. CONRADO M. CORPUZ bilang OIC ng tanggapan ng DENR CENRO-Brooke's Point, at ipinaabot ang reklamo ko laban kay Mr. Valdeztamon at sa kooperatibang pinangungunahan nya, at ito tinatakan nila na nareceived nila. Nakalakisap dito ang aking Complaint Letter dated August 27, 2021 bilang Annex - E.
6. Na noong August 31, 2021 ay dumating na sina Forest Technician I na si MELOSIN M. RATIB at Forester I na si MARLOU OLIVA SORETES mula sa opisina ng DENR CENRO-Brooke's Point, at sila ay nag-inspeksyon lamang sa area namin, at naroon din ang aking anak na si Bryan D. Contreras, at sina Mr. Valdeztamon at ang Punong Barangay Federico Dagwat ng Barangay Samarinana. Tiningnan lang nila ang lupa namin at nag-usap-usap lamang doon, pero hanggang ngayon ay walang maibigay na report sa amin ukol sa nangyaring pag-inspeksyon na iyon. At may mga kuha ng litrato si Bryan noong araw na iyon na nakalakisap sa kanyang Sinumpaang Salaysay na nakalakisap naman dito bilang Annex - F, samantala ang mga litrato na kuha ni Bryan nakalakisap bilang Annex - G at series.
7. Na noong November 14, 2021 ay muling pumasok sa area namin sila Mr. Valdeztamon at nagkutkut at nagkarga na nang mga graba ng walang pahintulot mula sa akin o sa mga anak ko. Nasaksihan rin ito ni Bryan at ni Mr. Morante, Sr, at may mga litratong kuha rin si Bryan na kasama rin nakalakisap dito bilang Annex - G at series.
8. Kaya noong November 15, 2021 ay agad muli akong nagpa-received ng letter complaint ko sa tanggapan muli ng DENR-CENRO-Brooke's Point, Palawan tungkol sa nangyaring ito. Ngunit, hanggang ngayon ay wala pa ring nagiging aksyon o resulta ang aking reklamo ko na ito. Ang pangalawang letter complaint ko na ito ay nakalakisap dito bilang Annex - H.
9. Na noong November 27, 2021 ay tinawagan ko sa cellphone ko si Mr. Corpuz tungkol sa aking reklamo at ang sabi nya nasa biyahe daw sya at hindi nya ako maintindihan, at kung kaya ibinaba na lamang namin ang tawag. Maya-maya ay nagtext na lamang sya ng sumusunod: "Sir nsa biyahe ako ngaun, nkausap ko na cla Ratib nsabi ko na reklamo nyo, mgsubmit cla ng report sa lunes. Pasensya po ngdrive ako ngaun. Ty" Na kinuhanan ng picture ang text message na ito mula sa aking cellphone, pina-print at inilakisap dito bilang Annex - I.
10. Na nang sumunod na lunes matapos iyon ay wala pa rin naging aksyon mula sa tanggapan ng DENR-CENRO-Brooke's Point, kung kaya matapos ang isang lingo ay nagpunta na ako muli ng personal sa kanilang tanggapan upang mag-follow-up, at nkausap kong muli si Mr. Corpuz at ang sinabi lang sa akin ay hintay-hintayin lamang ang report. at nagsabi pa sya na aaksyonan nila.



11. Ngunit matapos ang ilang buwan ay wala pa rin resolusyon sa aking reklamo, wala rin naging patawag na magkaroon man lang ng pag-uusap, wala rin abiso nang kung anu-mang aksyon patungkol sa aking reklamo, at higit sa lahat, noong nag-follow-up naman ako kay Mr. Ratib para sa kanilang report at ang naging sagot nito sa akin ay na kung nag-aapura daw ako ay magreklamo na lamang ako sa ombudsman.
12. Na dahil sa patuloy na hindi pag-aksyon nina Mr. Corpuz, pati na rin ng kanilang head ng kanilang MGB na si Engr. KATE GANRIELLE L. CASTILLO, pati nina Mr. Ratib at Mr. Soretas, ay kami ng mga anak ko ay patuloy na peperwisyo ng illegal na pag-pasok at pagkuha ng grupo ni Mr. Valdeztamon ng graba sa lupa namin nang walang pahintulot sa amin.
13. Kung kaya ako ay nagrereklamo ngayon sa hindi makatarungan na pagtugon sa aking reklamo ng opisina ng DENR-CENRO-Brooke's Point, at hindi nila pag-aksyon dito.
