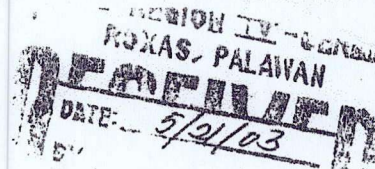




AFFIDAVIT

7. That I am executing this affidavit to prove the veracity of the foregoing statement and for the purpose of correcting an error which should be properly done by the CENRO, Roaxas, Palawan, to avoid any untoward incident within the premises.


