



In compliance with the issued CENRO Special Order No. 016 Series of 2022, the SMP Team of CENRO-Coron, Palawan conducted the Site Assessment, Survey, Mapping and Planning (SMP) for eNGP CY 2023 target located at Barangay Turda and San Nicolas, Coron, Palawan.

Please be informed that the Team commences the activity starting on July 05 to August 05, 2022, and conducts actual site assessment within the two (2) Barangay in the municipality of Coron, Palawan. The collection of soil samples for soil analysis has been conducted to determine the suitability of species to be planted in the area. The collected soil samples have been air dried for a particular number of days before soil analysis using the Soil Test Kit.

In addition hereto, the identification of rivers and creeks has been considered also to determine the availability of water for the nursery establishment and seedling production. Likewise, the identification of native species found in the area has been recorded to be the priority species to be planted.






To date, the activity for SMP has been completed that covers the 350 hectares for CY 2023 target except for report writing and the thematic maps of the assessed area.







Assessment on Proposed E NGP area for CY 2023
