This is in reference to the letter from Pag-asa Youth Association of the Philippines, San Vicente, Palawan Chapter to this office dated February 10, 2022 (copy attached) to have a mud-crab fattening project in the mangrove area in Barangay New Agutaya, San Vicente, Palawan. The members of the group are composed of out-of-school youths of the barangay and the project is part of the Youth and Livelihood Program of San Vicente's Municipal Social Welface and Development Office (MSWDO).

The Conservation and Development Section staff of this office conducted an inspection on March 1, 2022 in the proposed project site. The following are the findings:

- 1) The crab fattening area is about 226 sq. m. located in the inner part of the mangrove area where there is permanent water;
- 2) The project is deemed unobtrusive because it does not obstruct waterways for boats. The crab cages are made of nets and wood and are not permanent structures. The bunkhouse is the only permanent structure which is near the culture site; and,
- 3) The project is deemed non-exploitative and non-extractive since the area will only be used for crab fattening. The cages will be partially or totally submerged in the water

depending on the tide. The crabs will be harvested when it reached certain length and weight.

However, Presidential Proclamation 2152 s. 1981 declared the entire province of Palawan as Mangrove Swamp Forest Reserve and PCSD's ECAN Zoning automatically classifies mangrove areas as core zone.

In view that the proposed project is non-extractive, will not involve cutting of mangroves and will help to uplift the socio-economic conditions of the locals especially the out-of-school youth, this office proposes to have a Multi-Partite Agreement with the concerned LGU and the beneficiary/partner organization. Attached is draft of the Multi-Partite Agreement and other documents pertinent to this request.
