

AND INVENTORY THE ON REPORT **PROGRESS** COMMERCIAL MONITORING OF COMPLIANCE ISSUED WITH ESTABLISHMENTS AND HOUSEHOLDS NOTICES TO VACATE (NTV) IN EL NIDO, PALAWAN AS PART OF THE GREEN ECONOMY MODEL (GEM) PROJECT

This pertains to the target activity on the conduct of compliance monitoring on the delineated easement and inventory of affected establishments under the Enforcement of Laws and Regulations of the GEM Project under SAA No. CO-R4B-101-2021-07-514. Please be informed that the Inventory and Compliance and Monitoring Team had already conducted compliance monitoring activities of establishments and households issued with NTVs in Barangay Bucana, Buena Suerte, Corong-corong, Maligaya and Magana and inventory of structures within the legal easements of eight (8) barangays of the municipality namely Villa Libertad, Pasadeña, Teneguiban, Sibaltan, Manlag, Bagong Bayan, Aberawan and Bebeladan El Nido, Palawan. Hereunder is the summary of the households and establishments monitored by the team with the status of their compliances during the monitoring period:

Based on the monitoring conducted, out of the 157 NTVs issued for commercial establishments in five (5) barangays, only 45 establishments were found to be compliant, 111 were non-compliant and two (2) establishments were not found during the monitoring. These establishments were issued NTV for illegally encroaching easement areas and for occupying timberland areas without tenurial instruments. On the level of compliance, most of establishments particularly in Barangay Corong-corong are title holder, thus manifested 'no violation'.

Moreover, other commercial establishments listed had already submitted an appeal for consideration of their issued NTVs weeks after they received the said Notice but to date, they have not yet receive a response yet. There are also some establishments initiated demolitions of the portions of their property near the beach although they did not receive any NTV from the Office. Further, establishments in the urban barangays that initiated demolition of the portions of their property that falls within the marks of 3-meter easement previously established by Task Force El Nido Challenge were considered "compliant' especially those within the alienable and disposable land and title holders. Those establishments within timberland areas yet titled property were considered 'non- compliant' per Rule 24.4 of DENR Administrative Order No. 2019-05 dated May 30, 2019.

On the other hand, only 35 out of the 328 households in the master list were compliant, 243 were non-compliant and 42 households were not found during the monitoring. Some households have initiated self-demolition while others particularly those previously living on stilt houses at Sitio Takasan, Bgy. Corong-corong received financial assistance from the LGU and relocated in Sitio Bubulungan which is still a timberland area.

Also, majority of the households issued with NTVs are not bonafide residents of their respective barangay. Some are leasing for a rent-to-own property and during the onset of the pandemic, these NTV recipients had already vacated the area.

Further, the table below is the results of the inventory of commercial establishments and households in eight (8) barangays covered by the project.

Unfortunately, there were four (4) structures that cannot be identified due to most of the inventoried establishments were closed during the time of monitoring hence the very limited data collected besides that some of the caretakers interviewed have no knowledge on the data needed by the team and that the team were using the old inventory form.

Further, among the 38 inventoried houses, at least two (2) have titles, five (5) have tax declarations only and one (1) cadastral as basis for their occupation. Based on the data

### Aberawan

Most of the households inventoried in Aberawan are made of light materials and built within the mangrove areas. Some of these are accessible by boat; some are abandoned while some are residing in a titled property allegedly owned by Ms. Felicitas Velano. It was also noted that the subject lot was already subdivided as evident by the *mojons*. Further, only two (2) commercial establishments were recorded during the monitoring, one is the El Nido Beach Camp and Resort owned by Ms. Jenefer Tadalan and is operational since March 2022 and the other establishments/cottages are owned by the Ayala Corporation.

### **Bagong Bayan**

Out of the 19 inventoried houses, none have secured any documents as basis for their occupation and none of the household owners have secured easement clearance from the DENR. Only three (3) have sanitation facilities made of concrete. Majority of the households are getting source of water supply from surface water while others are from the local water distributor. Most of the households were built with light materials. It was also noted that some households were built and submerged in the water during high tide.

### Pasadena

Among the 14 establishments inventoried, three (3) properties were owned by Ayala Group of Companies and/or Ten Knots, Philippines, Inc. (TKPI) such as El Nido cove and its amenities Resort. Additionally, four (4) structures are owned by Tony Frey namely Kalasangan resort, rest house, cottages and beach bar. There are three (3) structures owned by private personnel which two (2) are just fenced and one (1) is an abandoned native hut.

Unfortunately, there were four (4) structures that cannot be identified due to most of the inventoried establishments were closed during the time of monitoring hence the very limited data collected besides that some of the caretakers interviewed have no knowledge on the data needed by the team and that the team were using the old inventory form.

Further, among the 38 inventoried houses, at least two (2) have titles, five (5) have tax declarations only and one (1) cadastral as basis for their occupation. Based on the data collected, none of the household owners have secured easement clearance and most have deep wells and septic tanks. Also, eight (8) of these structures are just fenced property. In addition, 11 structures were found already abandoned especially in Sitio Calampinay were most of the household received an NTV's. There is a one (1) household who refused to cooperate, with no concrete reason and that is Mr. Aram Dela Cruz. There were also four (4) inventoried structures whose owners were not identified. Additionally, one (1) concrete bridge structure is within the property of Royal Premiere.

### Sibaltan

A total of 19 establishments were inventoried, five are government facilities specifically the Philippine Coast Guard station with wharf, Sibaltan cemetery, and chapel and the Balay Cuyunun which is a project of the Municipal Tourism Office of El Nido. Out of the affected establishments, only the Kite Surfing and Roselyn Homestay were operational during the time of monitoring and that at least seven (7) have respective titles and two (2) have tax declarations. It was also disclosed that the accommodation of Mr. Alejo Acosta is just a family vacation house.

Further, among the 52 inventoried houses, at least seven (7) have titles, seven (7) have tax declarations only and four (4) have barangay certifications as basis for their occupation. Based on the data collected, none of the household owners have secured easement clearance and most have deep wells and septic tanks. Also, seven (7) of these structures are already abandoned including the boarding house of Ms. Elena Palma while four (4) structures inventoried are only perimeter fences and no house built yet. There were also four (4) inventoried structures whose owners were not identified.

#### Villa Libertad

A total of eight (8) structures were inventoried, four (4) of which belongs to Lio Tourism Estate (LTE), three (3) to Lio Airport and one (1) fish landing facility owned by private individual. The structures of LTE and Lio Airport are outside El Nido-Taytay Managed Resource Protected Area (ENTMRPA) and within titled/alienable and disposable lands except that of the wharf. The structures inventoried are not designed for accommodation and do not generate wastewater hence other permits/clearances do not apply (i.e. DOT accreditation, PAMB and other EMB permits).

Further, no household inventoried for the stretch of the beach of Villa Libertad. The easement in the mangrove/riverine areas in the barangay where there are informal settlers was not yet delineated and inventoried in this phase of the project.

Of the five (5) barangays that were completed, some of the issues and concerns encountered during the monitoring and inventory were:

- 1. Most of the inventoried establishments were closed during the time of monitoring hence there were very limited data collected besides that some of the caretakers interviewed have no knowledge on the data needed by the team;
- 2. Some of the caretakers/guards did not disclose any information about the area like who owns the structures, name of the structures, among others. Thus, the team resorted to made interview with the adjacent property to get the needed information; and
- 3. Some structures have titles and/or basis of occupation within the area and there are some occupants that were hostiles. Consequently, the team was hesitant to continue the interviews and inspection.

In view of the foregoing, the undersigned recommends the following:

- 1. Specific clarification should be laid down on the legal easement to be imposed within the four (4) urban barangays whether it is 40m instead of 3m easement as established by El Nido Task Force considering that the previous NTVs issued to them does not expressly provided as to the distant of legal easement to be complied with.
- 2. Re-delineation and re-demarcation of 40meter easement should be done after the Protected Area Suitability Assessment (PASA) particularly in urban barangays considering that it is still a protected area;
- 3. Since most of the violations are the Presidential Decree 705, PD 1067 and RA 11038, issuance of Show Cause Order for non-compliant establishments and households and structures falls within 40m legal easement per Rule 24.4 of DENR Administrative Order No. 2019-05 is necessary; and
- 4. A legal opinion should be provided for those patented area within timberland, easement zones and protected area.
