In compliance with Forestry Administrative Order No. 1, series of 1970. I have the honor to submit my Business Plan/Program as Lumber Dealer with place of operation at Purok Mapagmahal, Brgy. San Jose, Puerto Princesa City in connection with my application and issuance of Certificate of Registration as Lumber Dealer.

I. MARKETING PROGRAM

A. PRODUCTS

The products to be made and sold consist of different species of lumber/flitches out of planted trees from titled land and other tenured areas. The program involved the measurement of lumber purchased from legitimate suppliers.

B. PRICING STRUCTURE

The selling price of lumber will be taken into consideration. There are some factors that influence the pricing structure of lumber, these are cost of purchases, quality and groupings of lumber and other operational expenses. However, lumber prices ranges from Php40.00 to PhP60.00 per board feet (delivered) depending on the sizes and species.

C. DISTRIBUTION CHANNEL AND OUTLET

The lumber products will be sold to any buyer, wholesaler or retailer to local market within the City of Puerto Princesa and nearby municipalities of Province of Palawan. However, we can also sell the lumber to contractors of various National and Municipal Government and to the general public as a whole

D. USE OF PRIVATE AND GOVERNMENT PROMOTIONAL FACILITIES

No private or government promotion facilities will be utilized or tapped. Our promotional effort is mainly concentrated on customers visit to solicit their furniture requirements. The present marketing requirements and facilities consist of truck and top down which will be used in delivering lumber to our customers in order to augment their satisfaction.

II. PROMOTIONAL PROGRAM

A. DEVELOPMENT PLAN

The area of the establishment is about 1,025 square meters that will serve as the lumber yard. Portion of the lumber yard will be used for display of lumber, garage of truck and topdown and quarters of the laborer/employee.

B. PROCESSING SCHEDULE

The establishment does not process lumber into finish forms. Minor trimmings and plaining will be made. These will be done only as the demand arises upon request of customers.

C. EMPLOYMENT PROGRAM

The business is only single proprietorship wherein the owner is at the same time the manager. The mode of payment is based on the marginal profit of the business. There will be employed laborers who will be assigned in the maintenance of the lumber yard. These laborers are paid on the daily minimum wage per day plus allowance. Rest days during Sundays and holidays were also observed sometimes.






