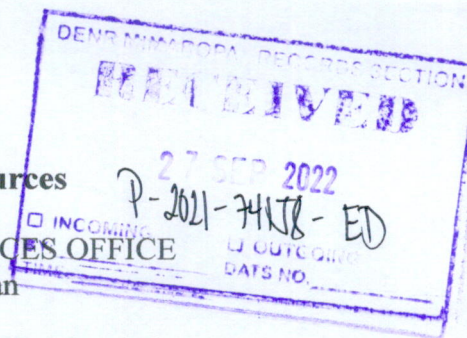



Per memorandum, CENRO Puerto Princesa sent a letter dated January 2, 2020 to the former Municipal Mayor of Aborlan Hon. Celsa B. Adier inviting her to visit their office in order to discuss the process and procedures in the conversion of the issued SLUP to a FLAg. On June 4, 2020 CENRO Puerto Princesa received a letter from Mayor Celsa B. Adier expressing her intention to convert the four (4) SLUPs into FLAg. The said letter was immediately responded providing her the checklist of requirements for FLAg. However, there was no compliance on the part of LGU-Aborlan up to this date.

This has reference to the Memorandum dated July 1, 2022 from OIC-ARD for Technical Services Maximo C. Landrito PENRO Memorandum dated August 2, 2022. It pertains to the four Special Land Use Permit (SLUP) for water system issued to the Municipal LGU of Aborlan, Palawan which already expired on January 16, 2020.

Please be informed that prior to the expiration of 4-SLUPs awarded to Aborlan-LGU, this Office sent a letter dated January 2, 2020 to the former Municipal Mayor of Aborlan Hon. Celsa B. Adier inviting her to visit our Office in order to discuss the process and procedures in the conversion of the issued SLUP to a FLAg. Section 14 of DAO No. 2004-59 and item No. 13 of the additional terms and condition of the permit were cited in the said letter, to quote **"The permit is non-renewable. Should there be a need for extended use of the forest land, a Forest land Use Agreement (FLAg) should be applied for provided that the holder has shown satisfactory performance based on the results of evaluation and has fully complied with the terms and condition of the permit"** unquote (copy of letter hereto attached).

However there was no response from the LGU-Aborlan, hence on June 1, 2020 another letter addressed to former Municipal Mayor Celsa B. Adier was sent by this Office (copy of said letter hereto attached).

On June 4, 2020 this Office received a letter from former Mayor Celsa B. Adier expressing her intention to convert the four (4) SLUPs for water system issued to them into FLAg. The said letter was immediately responded by this Office by providing her the checklist of requirements for FLAg for her guidance and compliance (copy of said letter attached).

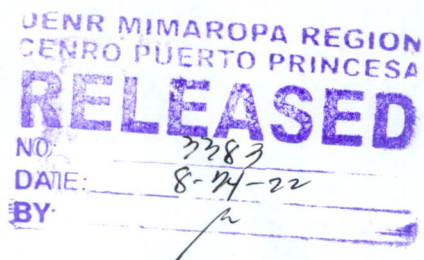
