



INTRODUCTION

The monitoring and evaluation team headed by Chief, Compliance and Monitoring Unit (CMU) Mr. Mark Glenn Managdag, conducted monitoring and ground inspection on the proposed bathing establishment of Ms. Jennifer B. Corpuz on August 24, 2022, located at Sitio Lahid-Tahom, Barangay Galoc, Culion, Palawan. It took about two (2) hours of boat ride before reaching the area.

FINDINGS/OBSERVATIONS

Upon reaching the seashore, two guards were observed stationed conducting monitoring and patrol within the vicinity of the FLAG-T area, while securing the property. No significant improvement was observed established in the area besides from a small hut made from very light

materials which served as security guard's quarters. There is a source of freshwater present in the area, coming from water well they built.

The forest cover within the area is still intact and no human disturbance or destruction was observed. There are also sightings of wildlife such as monitor lizard and various avian species roaming within the vicinity of the area.

They conducted mangroves and tree planting activities as participation for conservation and protection of the environment, wildlife and natural resources. Mangrove propagules and coconut seedlings observed planted well round in the area.

RECOMMENDATIONS


Based on the ground inspection and evaluation conducted, the team recommended that the proponent should start to developed the area and put more improvements such as erecting buildings, cottages and a small port or boat landing for incoming visitors. This plans and developments will lead to generate more jobs and opportunities especially for local people and coastal communities that will clearly benefit for the continuation of the project. It is also highly recommended that the proponent should submit their annual report and directly send to the Regional office of the DENR. The proponent already complied with their financial obligations to the government.





Beachfront and seashore of the proposed bathing establishment of Ms. Jennifer B. Corpuz


