I. FACTUAL BACKGROUND

On July 29, 2022, at around 9:40 A.M. this office received an information through mobile communication, from a concerned citizen, that a number of lumbers are seen on the roadside of Brgy. Tubigon, Ferrol Romblon.

II. LEGAL BASIS

P.D. 705 Revised Forestry Code of the Philippines as amended by E.O. 277 and further amended by R.A. 7161

Section 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products without License. – Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code: Provided, That in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.

III. ACTIONS TAKEN

The personnel from Monitoring and Enforcement Section composed of Special Investigator Ann Adriguez and Forest Ranger Michelle Bajo along with Forest Technician Rodel Gonzales, proceeded to the area to verify the information.

The team coordinated with PSMS Churchill S Javier, Duty Desk Officer of Ferrol Municipal Police Station and Brgy. Kagawad Danny Aungon of Tubigon, Ferrol, Romblon. The team, then proceeded to the area and was accompanied by PSSg Archie D Ferranco and PCpl Denver T Teologo.


IV. FINDINGS

The following are the results of the verification conducted:

1. There are 8 pcs abandoned mahogany lumbers found shaded on the roadside of Tubigon, Ferrol, Romblon
2. The lumbers are scaled by FT Rodel Gonzales and FR Michelle Bajo which totaled to 39 board feet and estimated to have amounted to Php 1, 950.00. These are enumerated as follows:
 - 1 pc 2x3x14
 - 3 pcs 2x3x12
 - 1 pc 2x3x10
 - 1 pc 2x6x5
 - 2 pcs 2x3x4

Through the assistance of PNP personnel and on-duty barangay official, said lumbers were hauled to this office and will remain in custody until after posting of notification or until claimed. Posting of notice of abandoned lumbers shall be done at Tubigon, Ferrol, Romblon.




