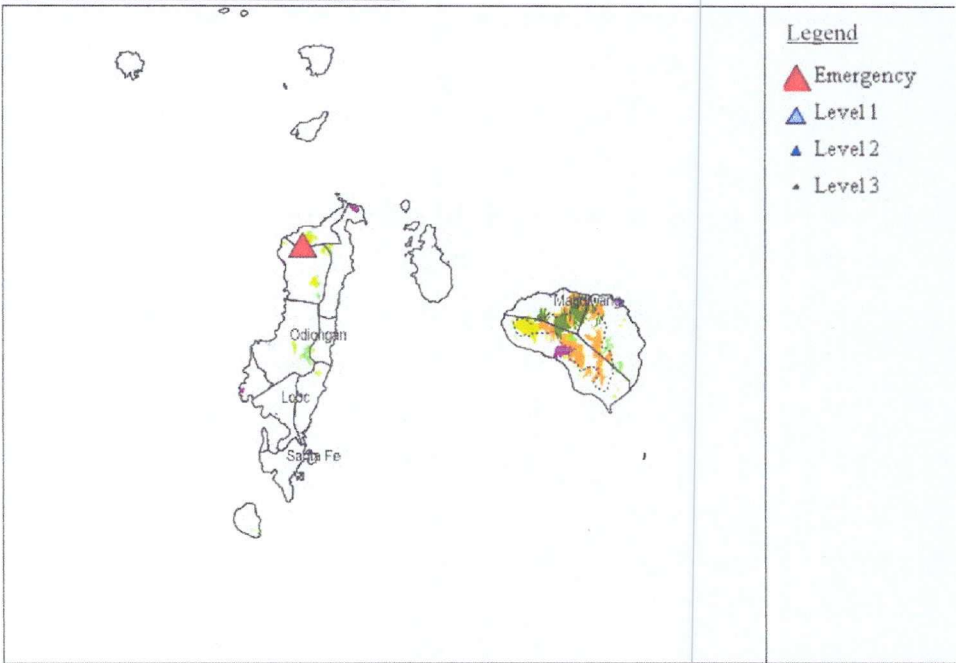

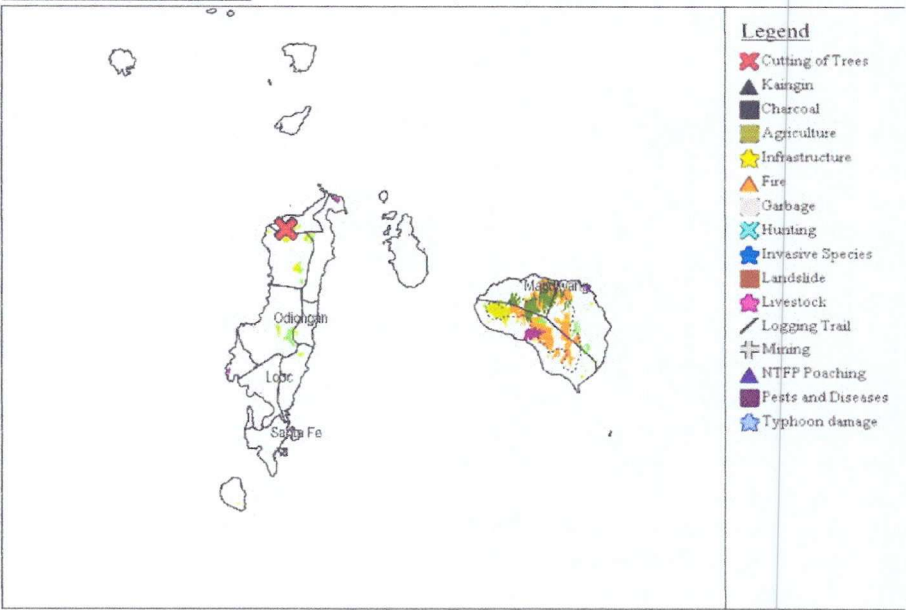

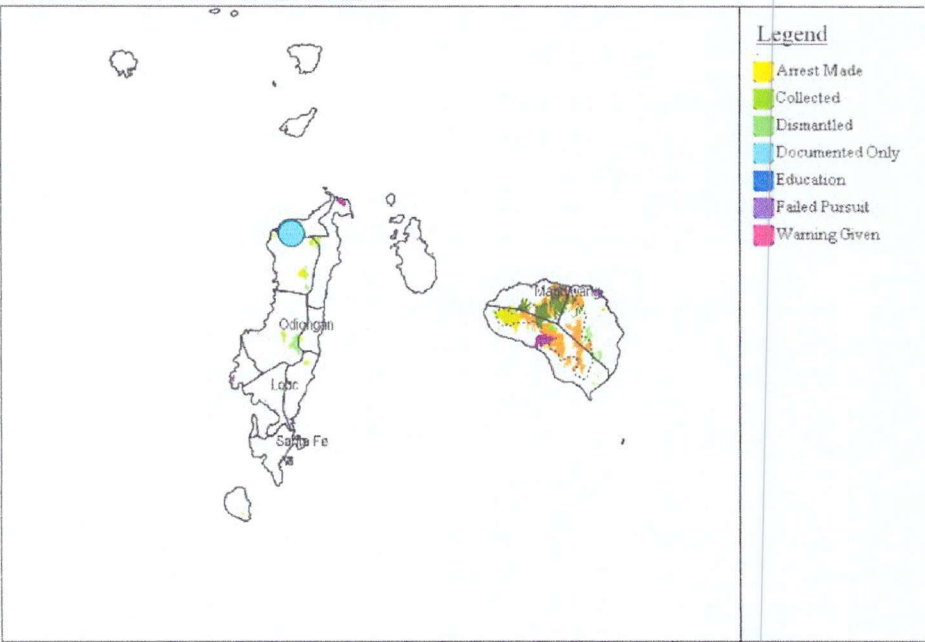
Locations and urgency of responses needed

Locations of actions taken to address threats





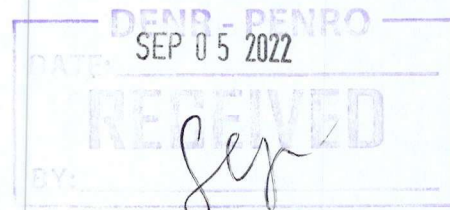

Respectfully submitting the summary report of patrolling using LAWIN Biodiversity and Forestry Protection System conducted in Sibuyan Island, Romblon from July 21- August 20, 2022 to wit;

Records and observations collected by the data manager of SMART LAWIN from the three (3) patrol teams shows that a total of **36.26** kilometers were patrolled from July 21- August 20, 2022.

Forest Patrolling in Mt. Guiting-Guiting Natural Park is now regularly conducted by three (3) LAWIN group patrollers. The DENR hired newly (10) Park Rangers and (3) Forest Protection Officers and the Philippine National Police and Philippine Coastguard also team up with the DENR for more man power to help prevent illegal forest activities in the area.

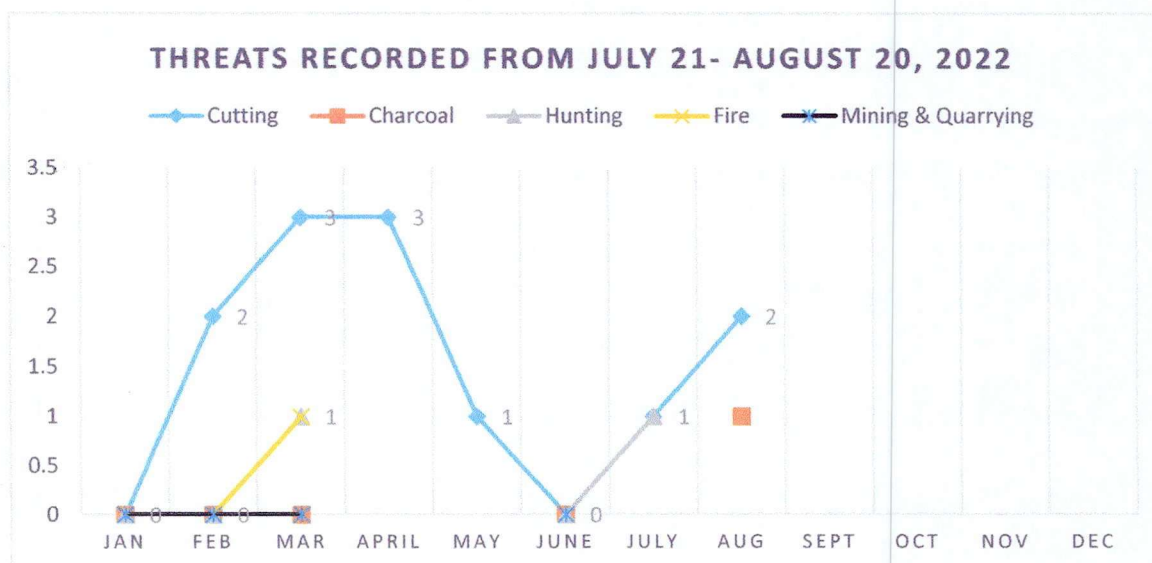
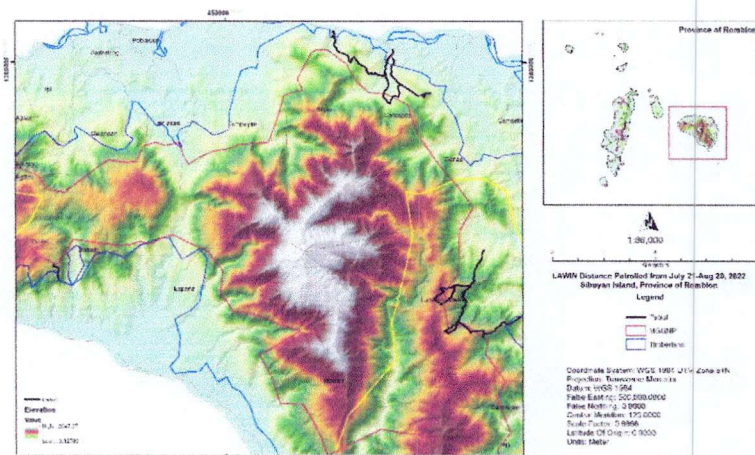
There were apprehensions documented outside the forest conservation area within the vicinity of Brgy. Espana, San Fernando, Romblon which led to successful apprehension of abandoned lumber and also in Brgy. Cambajao, Cajidiocan and One (1) unit of top-down tricycle illegally transporting charcoals were also apprehended while passing in the DENR guard post in Brgy. Espana, San Fernando, Romblon.

The Data Manager generated a single patrol report for every team who conducted the patrolling for easy and accurate monitoring of their action taken on the recorded threats. A total of **460.22** kilometers were recorded by the data manager from January 2022 to present.

There are two (2) illegal abandoned lumber were apprehended outside the conservation area and one (1) unit tricycle were apprehended in Brgy. Espana, San Fernando, Romblon and Brgy. Cambajao, Cajidiocan, Romblon. These incidents were not recorded in the cybertracker apps.



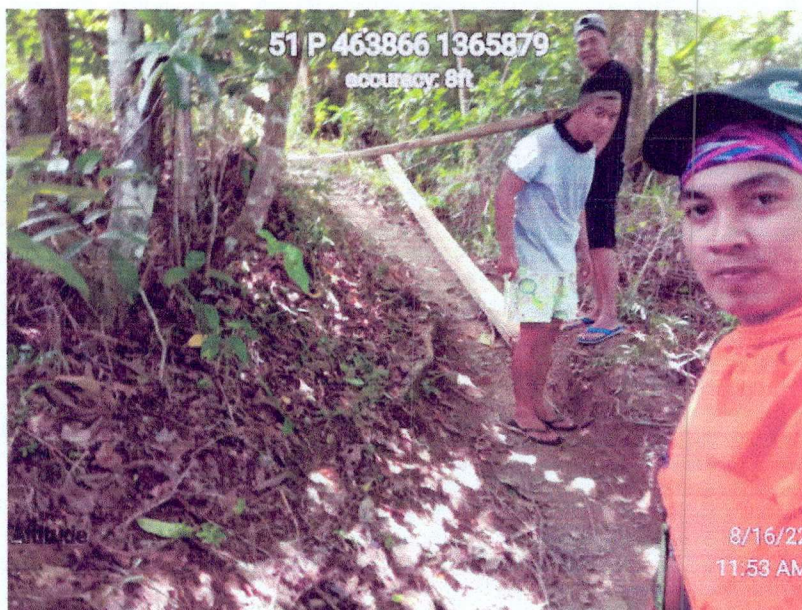
Graph showing the kilometers patrol recorded by the patrollers.



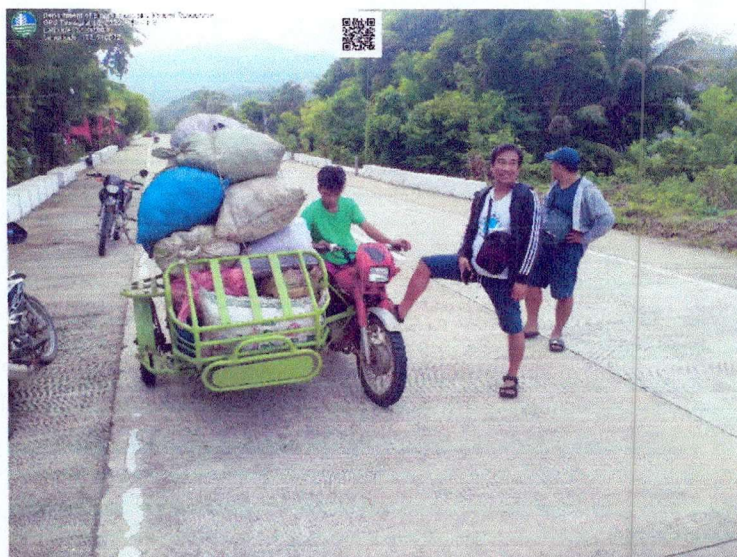
Apprehended abandoned lumbers in Brgy. Espana, San Fernando, Romblon



Apprehension in Brgy. Cambajao, Cajidiocan, Romblon

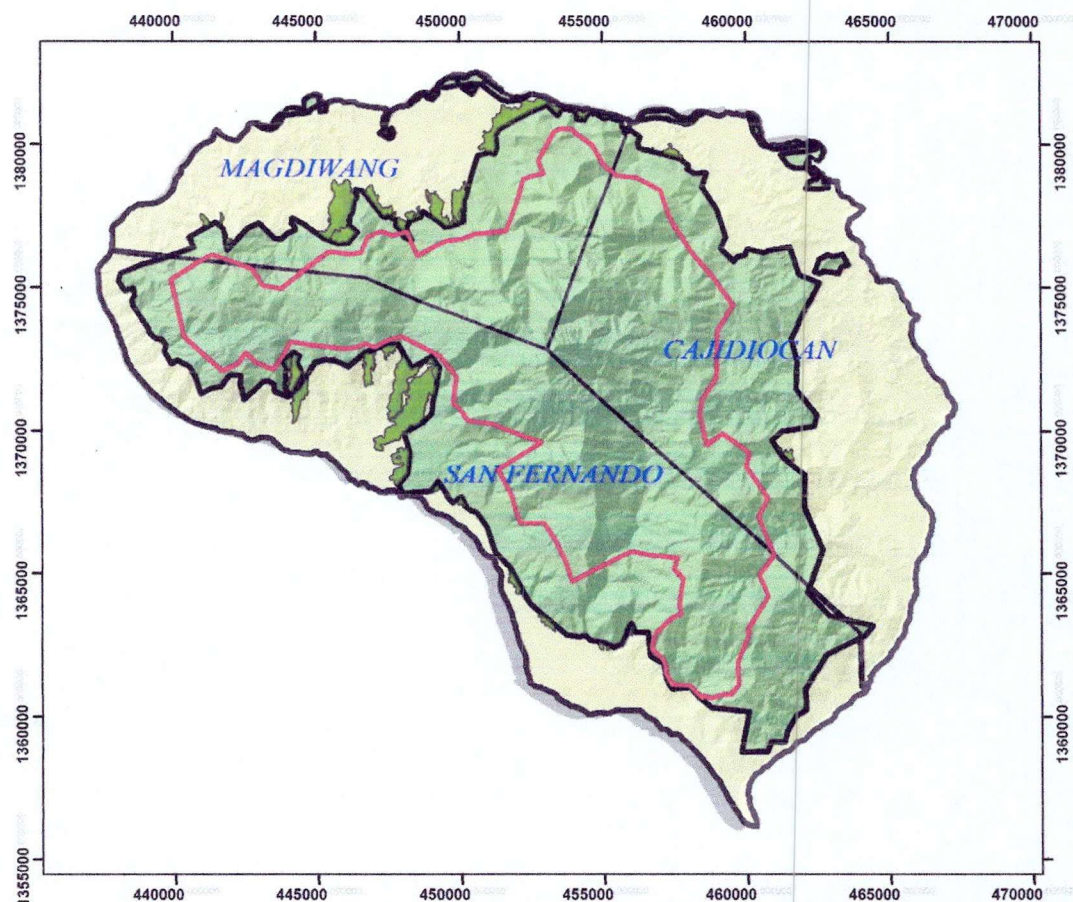


Apprehension of one (1) unit tricycle in Brgy. Espana, San Fernando, Romblon
