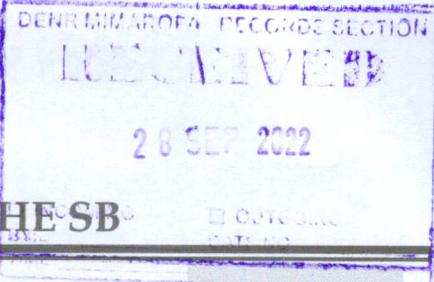

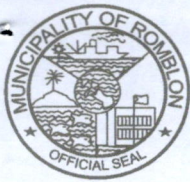

A RESOLUTION AUTHORIZING MUNICIPAL MAYOR GERARD S. MONTJOJO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT & NATURAL RESOURCES (DENR) MIMAROPA REPRESENTED BY REGIONAL EXECUTIVE DIRECTOR LORMELYN E. CLAUDIO, CESO IV, FOR THE IMPLEMENTATION OF THE MUNICIPAL FOREST LAND USE PLAN (FLUP) OF LGU-ROMBLON

WHEREAS, Article 87 (b) (I) (iv) of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that the Municipal Mayor upon authorization by the Sangguniang Bayan shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinances;

WHEREAS, presented before this august body is an Endorsement from Hon. Mayor Gerard S. Montjojo dated 23 August 2022 of a draft Memorandum of Agreement between the Department of Environment & Natural Resources (DENR) MIMAROPA Region and the Municipal Government of Romblon, requesting for the enactment of resolution of authority for the Honorable Mayor to sign the same for and in behalf of the local government unit;

WHEREAS, the Forest Land Use Plan (FLUP) defines technical and governance strategies to conserve forest, water and biodiversity resources; increase food and fiber production; direct and focus public and private investments; eliminate or significantly reduce conflicts among stakeholders and protect lives, settlements and public infrastructures;

WHEREAS, after due consideration and careful study, this body finds that the adoption of such will be beneficial to the constituents of this municipality and for the protection and management of its forests;

NOW THEREFORE, on motion of Councilor Fernando R. Faigao III duly seconded by all the members of the Sangguniang Bayan present in session, be it –

RESOLVED AS IT IS HEREBY RESOLVED to authorize as it is hereby authorizes Municipal Mayor Gerard S. Montojo to enter into a Memorandum of Agreement (copy hereto attached and made an integral part hereof) with the Department of Environment & Natural Resources (DENR) MIMAROPA represented by Regional Executive Director Lormelyn E. Claudio, CESO IV, for the implementation of the Municipal Forest Land Use Plan (FLUP) of LGU-Romblon;

RESOLVED FURTHER that copies of this resolution be furnished Hon. Municipal Mayor Gerard S. Montojo; Regional Executive Director Lormelyn E. Claudio, CESO IV, Department of Environment & Natural Resources (DENR) MIMAROPA Region with office address at Bay Bldg. 1515 L&S Bldg. Roxas Blvd. Ermita Manila, and the Sangguniang Panlalawigan of Romblon, for their information, reference and guidance.
