



WHEREAS, Barangay Port Barton is located at the westcoast in the middle of the Province of Palawan has been hit by the eye of typhoon Odette last December 17, 2021 that resulting of a big daages to barangay Government Infra structures, houses pumpboats being used by the boatmen to cater our tourists and also fishermen who rely of their livelihood and overcome its daily needs of the family, the wide areas of the farmers has been also destroyed.

WHEREAS, there are huge of Planted trees and forest tress being felled -down around the barangay during the devastation of the said super Typhoon Odette ,

WHEREAS, there was a submitted list of affected families with its damages to their houses and livelihood of the constituents conducted and made by the nineteen (19) purok/sitios leaders to the barangay Local Government in order to seek assistance for recovery of every affected families;

WHEREAS, the barangay Local Government of Port Barton had submitted of some lists of affected families and a request to utilized some felled trees to be given to the super typhoon Odette victims that is really badly needed for them to surpass into the present economy crises made by the Covid-19 Pandemic and now the Super typhoon Odette.

WHEREAS, as per personal conversation to the Department Head of the DENR-CENRO, Roxas Palawan, Mr. PABLO L. CRUZ CENRO, the wood recovery permit application for Barangay Port Barton had been submitted and endorsed to the Office of the DENR Region IV_B and awaits its final approval to legalized its utilization of the felled timbers augment the needs of the community for re-construction of their shelter/houses and Pumpboats and also the Government Infra-structures;
