immediate investigation relative thereto.*

Dir. LORMELYN E. CLAUDIO, Sirs and Madam:

The undersigned is the compulsory heir of the late Lorenzo Ramiro, who during his lifetime, and for more than five decades, had been the possessor in the concept of an owner of Lot 2848 of CAD 612-D, Torrijos Cadastre in the province of Marinduque.

That I and my siblings namely: Rodolfo, Protacio, Eliseo, Antonio, and Paz together with grandchildren Orlando and Joel both son of Protacio (deceased) and Eliseo (deceased) who represent on their behalf, all surname Ramiro, being the legal successors of our late father, Lorenzo Ramiro, have only come to an agreement (Extra Judicial Settlement of Estate) with waiver of rights in favor of the undersigned concerning the adjudication of the afore-mentioned real property which possessory rights belongs to our late grandfather, last July 09, 2021.

Unknown to our knowledge, the aforesaid real property was caused to be subdivided by an unscrupulous private individual named AUGUSTO REY, who is not an heir and has no legal personality to do so, with the aid of an employee of PENRO Marinduque named LUCIANA M. RICAFFRENTE and thereafter, submitted the same to this Regional Office for approval. SUCH ACTION WAS DONE CLANDESTINELY, ILLEGALLY, FELONIOUSLY AND WITHOUT OUR CONSENT.

The signature of conformity appearing to the approved subdivision plan with No. Csd-4B-003255-D IS NOT THE SIGNATURE OF ANYONE AMONG US (heirs) hence a forged and/or fictitious signature.

Given the foregoing, may I therefore humbly request this Honorable Regional Office to conduct immediate investigation regarding this anomaly and to cancel immediately Subdivision Plan with No. Csd-4B-003255-D having the same unlawful and prejudicial to the best interest of the lawful heirs.

May I also request that all applications for residential patent concerning the subject real property, should there be, be immediately denied due course pending results of your investigation.

In the light of transparency and fair play, may I respectfully request that the investigation be conducted directly by the MIMAROPA Regional Office and be held in the City of Manila having an employee of the PENRO Marinduque is directly involved in this anomaly.

May I also ask the indulgence of the Regional Executive Director to reserve my right to file the corresponding legal actions (administrative, civil and criminal) against the erring employee of PENRO Marinduque before the office of the Honorable Ombudsman. Likewise at the Department of Justice against the private individual who connived with the PENRO Marinduque employee for gross fraud.

Attached are faithful reproductions of our pertinent documents establishing our rights being the heir of Lorenzo Ramiro for your perusal and consideration.

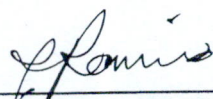
1. We are the surviving heirs of the late LORENZO RAMIRO being the later's children;
