<b>FACILITIES</b>	<b>REMARKS</b>
1. Ranger Station (1)	Aside from its function as Ranger Station, the facility is being used as temporary office of MCWS-PAMO Staff, venue during the conduct of meetings and other activities.
2. Monitoring Stations (3)	Monitoring stations located at Sitios Kalangigan, Pinagbayanan and Hinugasan, all located in Brgy. Harrison, Paluan, Occidental Mindoro are well maintained and can be used by the PA Rangers as their temporary shelter during patrol works.
