SUBJECT: DESIGNATION OF PROTECTED AREA SUPERINTENDENTS OF MTS. IGLIT-BACO NATURAL PARK (MIBNP) AND MT. CALAVITE WILDLIFE SANCTUARY (MCWS) AND UNIT HEADS OF DENR OFFICES IN THE PROVINCE OF OCCIDENTAL MINDORO

In the interest of the service and pursuant to Section 10 of RA 7586 as amended by RA 11038, DENR Special Order No. 2020-148, and DAO 2019-01, the following personnel of DENR Occidental Mindoro are hereby designated as follows:

Forester II Diosdado Torrado and Orlando Ramos shall return to CENROs Sablayan and San Jose, respectively, upon proper turnover. Their duties and responsibilities shall be decided by the PENRO and respective CENROs.

The PENRO Occidental Mindoro shall ensure that technical personnel shall be assigned at the PAMOs to aid in effective protected area management implementation, until such time that the appointment of *permanent plantilla positions* per Section 11-B of RA 7586 as amended by RA 11038 has been fully implemented.

The designated PASus shall perform the duties and responsibilities consistent with Section 11-B of RA 7586, as amended by RA 11038, while the designated Unit Heads shall perform the functions stipulated in DAO 2019-01.

They shall inform this Office of their compliance to this Order for record purposes.

This Order shall take effect immediately, supersedes all inconsistent Orders, and remains in effect until revoked in writing.
